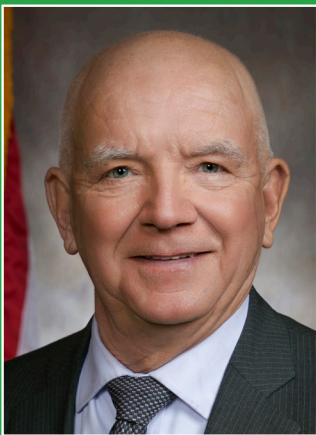

PROMOTING COMMUNITY BASED EMPLOYMENT FOR PEOPLE WITH DISABILITIES

A couple of years ago, I participated in a community discussion in Medford focused on employing people with disabilities. At this event, I learned about the Employment First movement which is the promotion of competitive integrated employment (CIE). CIE is the employment of individuals with disabilities in a workplace in the community working alongside people without a disability. I was pleased to learn that the Medford area is a leader in promoting Employment First policies, however, I also learned that barriers still exist for some disabled individuals who wish to work in the community.

Since that day, I have worked with various stakeholders and state agencies to draft legislation that promotes Employment First policies, while also preserving choice of allowable services. The result of this work is Assembly Bill 625/Senate Bill 514, the Employment First Bill.

Several state agencies are responsible for funding services to help youth and adults with disabilities find employment. However, there are times when these services are fragmented or duplicated. The Employment First Bill requires the state agencies who provide these services to collaborate and develop a joint plan to assist people with disabilities in finding employment in the community. This collaboration will make these services more effective for the people who need them and make it easier for these people to get the support they need to find and keep a job.

With enactment of this legislation, Wisconsin will be a model for the nation in promoting Employment First policies. I am proud to author this bi-partisan legislation with Rep. Anderson (D-Fitchburg) and Sen. Tiffany (R-Hazelhurst) and I hope that by the time this newsletter reaches your mailbox, this bill will have been enacted into law.



For the bill's public hearing back in January, a large group from the Medford area came to Madison to testify in support of the bill. The students who spoke did such a great job that they received a standing ovation!

PROMOTING YOUNG ENTREPRENEURS

Over the past few years, Wisconsin's business climate has improved significantly, but one area where we continue to struggle is in the area of small business startups. For the economic health of our state to remain strong, it is important that we find new ways to attract and retain young entrepreneurs. Unfortunately, all too often, young entrepreneurs who graduate from our state's colleges and universities leave the state after graduation for better opportunities.

That is why I introduced Assembly Bill 498/Senate Bill 404, which seeks to change that by removing a barrier to entrepreneurship and incentivizing student entrepreneurs to start a business right here in Wisconsin. This bill exempts students, who are at least 18 years of age and enrolled in a post-secondary institution in Wisconsin, from paying the initial \$130 filing fee for creating a limited liability company (LLC).

This exemption would remove one of the hurdles to starting a business for young entrepreneurs, and would also free up more resources for them to get their small businesses off the ground. This legislation makes starting a small business in Wisconsin more desirable and achievable for the next generation of entrepreneurs. This proposal has cleared the legislature and I hope to see it signed into law soon.

STANDING UP FOR RURAL WISCONSIN

As your representative, I am a proud advocate for rural Wisconsin. At times in Madison, this can be a lonely job, but it is a job that has to be done. I often hear that the voice of rural Wisconsin is not being heard in Madison. That is why I joined with several of my colleagues to form the Rural Wisconsin Initiative (RWI). The RWI is a group of rural legislators committed to making the voice of rural Wisconsin heard in Madison. The focus of the RWI is to bring forward policy solutions to improve access to education, health care, technology, and workforce development in rural Wisconsin.

This session, two RWI health care proposals were adopted as part of the state budget. These proposals increase funding for Advanced Practice Clinicians and Allied Health Professionals, two areas that have shortages in our state. These budget provisions create new grant programs to help train these health professionals which will help to fill vacancies in these fields in rural Wisconsin.

Another major accomplishment for rural Wisconsin in the state budget is the increased funding for the Broadband Expansion Grant Program. These grants allow un-served or under-served areas to apply for funding to expand or improve their internet services. I am happy to say that the budget I supported included an additional \$14 million for this important program.

I continue to work with my colleagues to find new ways to provide reliable broadband internet service such as TV White Space Technology. This new technology involves the transmission of internet signals over TV white space (unused space between TV stations). For this idea to become a reality, the Federal Communications Commission would need to adopt regulations to allow this technology to be used. I joined with several of my colleagues to bring forward a Joint Resolution in support of TV White Space Technology.

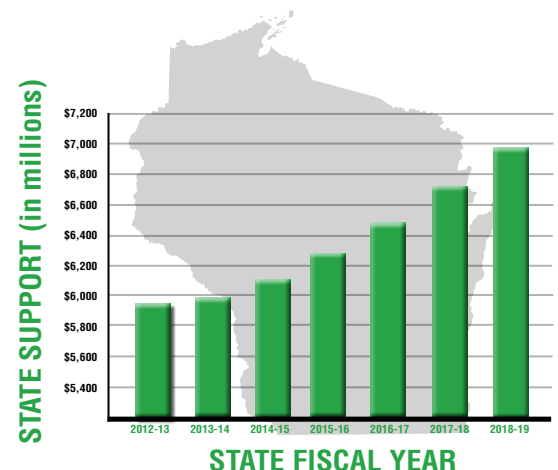


WORKING ACROSS THE AISLE

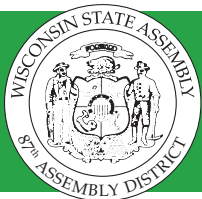
