2013 BILL

1 AN ACT to create 100.545 of the statutes; relating to: restricting the release of

 $\mathbf{2}$

credit information about certain protected individuals and providing a penalty.

Analysis by the Legislative Reference Bureau

Current law generally allows an individual to prohibit a consumer reporting agency (CRA) from releasing the individual's consumer report (credit report) for any purpose related to the extension of credit without the individual's prior authorization. If an individual makes a proper request to a CRA, provides proper identification, and pays any applicable fee, the CRA must include a "security freeze" on the individual's credit report. A CRA may not release an individual's credit report for an extension of credit if the report includes a security freeze. There are various exceptions to these requirements, including CRAs to which the requirements do not apply and exceptions allowing a CRA to release an individual's credit report that includes a security freeze for specified purposes or under specified circumstances. Current law also includes procedures for an individual to authorize release of a credit report that includes a security freeze. In addition, a CRA must remove a security freeze upon an individual's request, but may charge a fee to do so.

This bill provides for additional security freezes by allowing representatives to obtain security freezes on behalf of protected consumers. The bill defines a "protected consumer" as either: 1) an individual who is under 16 years old; or 2) an individual for whom a guardian or conservator has been appointed. The bill defines a "representative" as a person who provides "sufficient proof of authority" to act on behalf of a protected consumer, which is defined to include: 1) a court order; 2) a power of attorney; or 3) a notarized statement describing the authority to act on

behalf of a protected consumer. Under the bill, a representative may request a security freeze for a protected consumer by providing a CRA with the sufficient proof of authority described above, as well as "sufficient proof of identification" of both the representative and protected consumer. The bill defines "sufficient proof of identification" to include: 1) a social security number (SSN) or copy of a SSN card; 2) a certified or official copy of a birth certificate; or 3) a copy of a motor vehicle operator's license or identification card.

If a CRA receives a representative's request for a security freeze on behalf of a protected consumer, and the CRA already has a file on the protected consumer, the CRA must place a security freeze that prohibits the CRA from releasing the protected consumer's credit report. If the CRA does not have a file on the protected consumer, the CRA must place a security freeze by creating a record identifying the protected consumer. The bill prohibits using the record for credit considerations. The bill requires a CRA to verify that it has no file by checking names and SSNs in its existing files. The bill requires a CRA to place a security freeze within 30 days after receiving a request that complies with the bill, regardless of whether the CRA already has a file on the protected consumer. Upon placement of a security freeze, the CRA may not release the protected consumer's credit report, any information derived from the credit report, or any record created under the bill, unless the security freeze is removed as discussed below.

The bill also does the following:

1. Creates procedures for representatives and protected consumers to have CRAs remove security freezes and allows CRAs to remove security freezes based on material misrepresentation of fact by representatives or protected consumers.

2. Allows CRAs to charge a reasonable fee not exceeding \$10 for placing or removing security freezes, but prohibits fees in cases involving identity theft or protected consumers under 16 years old who already have files at CRAs.

2. Creates exceptions from the bill's requirements, including the exceptions that apply to security freeze restrictions under current law, as well as exceptions for information used for criminal records, fraud prevention or detection, personal loss history information, or certain background screening purposes.

3. Allows the Department of Agriculture, Trade and Consumer Protection and the Department of Justice to bring actions to enforce the bill's requirements.

4. Subjects a person who violates the bill to a civil forfeiture of not more than \$1,000 per violation.

SECTION 1. 100.545 of the statutes is created to read:

8	2. An individual for whom a guardian or conservator has been appointed.
9	(d) "Record" means a compilation of information about a protected consumer
10	that satisfies all of the following:
11	1. The compilation identifies the protected consumer.
12	2. The compilation is created by a consumer reporting agency solely for the
13	purpose of complying with this section.
14	(e) "Representative" means a person who provides to a consumer reporting
15	agency sufficient proof of authority to act on behalf of a protected consumer.
16	(f) "Security freeze for a protected consumer" means one of the following:
17	1. If a consumer reporting agency does not have a file pertaining to a protected
18	consumer, a restriction placed on the protected consumer's record that prohibits,
19	except as provided in this section, the consumer reporting agency from releasing the
20	protected consumer's record.
21	2. If a consumer reporting agency has a file pertaining to the protected
22	consumer, a restriction placed on the protected consumer's credit report that
23	prohibits, except as provided in this section, the consumer reporting agency from
24	releasing the protected consumer's credit report or any information derived from the

1 (g) "Sufficient proof of authority' means documentation that shows a 2 representative has authority to act on behalf of a protected consumer, including any 3 of the following:

1. An order issued by a court.

2. A lawfully executed and valid power of attorney.

6 3. A written, notarized statement signed by a representative that expressly
7 describes the authority of the representative to act on behalf of a protected consumer.

8 (h) "Sufficient proof of identification" means information or documentation 9 that identifies a protected consumer or a representative of a protected consumer, 10 including any of the following:

- A social security number or a copy of a social security card issued by the social
 security administration.
- 13 2. A certified or official copy of a birth certificate issued by the entity authorized14 to issue the birth certificate.
- 3. A copy of an operator's license issued under ch. 343 or under a comparable
 law of another state, an identification card issued under s. 343.50 or under a
 comparable law of another state, or any other government issued identification.
- 18 (2) EXCEPTIONS. This section does not apply to the use of a protected consumer's19 credit report or record by any of the following:
- (a) A person administering a credit file monitoring subscription service to
 which the protected consumer has subscribed or the representative of the protected
 consumer has subscribed on behalf of the protected consumer.

(b) A person providing the protected consumer or the protected consumer's
representative with a copy of the protected consumer's credit report on request of the
protected consumer or the protected consumer's representative.

A record created under this 3 paragraph may not be used to consider the protected consumer's creditworthiness, 4 credit standing, credit capacity, character, general reputation, personal 5 characteristics, or mode of living. 6 (c) Within 30 days after receiving a request that meets the requirements of par. 7 (a), a consumer reporting agency shall place a security freeze for the protected 8 consumer. 9 (d) Unless a security freeze for a protected consumer is removed in accordance with sub. (4) or (6), a consumer reporting agency may not release the protected 10 11 consumer's credit report, any information derived from the protected consumer's credit report, or any record created for the protected consumer. 1213 (e) A security freeze for a protected consumer placed under par. 1	2. Provide to the consumer reporting agency sufficient proof of identification

6	b. For a request by the representative of the protected consumer, sufficient

10	(b) Within 30 days after receiving a request that meets the requirements of par.
11	(a), the consumer reporting agency shall remove the security freeze for the protected

13	(5) FEES. (a) Except as provided in par. (b), a consumer reporting agency may
14	not charge a fee for any service performed under this section.
15	(b) A consumer reporting agency may charge a reasonable fee, not exceeding
16	\$10, for each placement or removal of a security freeze for a protected consumer.
17	(c) Notwithstanding par. (b), a consumer reporting agency may not charge any
18	fee under this section if any of the following applies:
19	1. The protected consumer's representative has obtained a police report or
20	affidavit of alleged identity fraud against the protected consumer and provides a
21	copy of the report or affidavit to the consumer reporting agency.
22	2. A request for the placement or removal of a security freeze is for a protected
23	consumer who is under the age of 16 years at the time of the request and the
24	consumer reporting agency has a file pertaining to the protected consumer.

(6) MATERIAL MISREPRESENTATIONS. A consumer reporting agency may remove 1 $\mathbf{2}$ a security freeze for a protected consumer or delete a record of a protected consumer 3 if the security freeze was placed or the record was created based on a material 4 misrepresentation of fact by the protected consumer or the protected consumer's $\mathbf{5}$ representative.

(7) PENALTY; ENFORCEMENT. (a) A person who violates this section may be required to forfeit not more than \$1,000 for each violation. 7

8 (b) The department of agriculture, trade and consumer protection or the 9 department of justice, after consulting with the department of agriculture, trade and 10 consumer protection, may bring an action for temporary or permanent injunctive or 11 other relief for any violation of this section or an action for the penalty authorized 12in par. (a).

SECTION 2. Effective date.

14(1) This act takes effect on January 14, 2014, or on the day after publication, whichever is later. 15
