# WISCONSIN JANUARY UNEMPLOYMENT RATE DROPS TO 6.9 PERCENT

# State gains an estimated 15,700 private-sector jobs between Dec. '11 and Jan. '12

MADISON – The Department of Workforce Development (DWD) today released the U.S. Bureau of Labor Statistics (BLS) preliminary data for January 2012, showing Wisconsin's unemployment rate dropped to 6.9 percent (seasonally adjusted) from a revised 7.0 percent in December 2011 and 7.7 percent in January 2011. Wisconsin also added 15,700 private-sector jobs on a preliminary basis from December 2011 to January 2012.

"Wisconsin's preliminary January unemployment rate of 6.9 percent is now the lowest it has been since December of 2008, and it remains well below the national rate," Secretary Newson said. "In addition, the preliminary monthly job estimates show growth across most industry sectors."

## **Unemployment Rate**

Based on unemployment insurance claims and a monthly survey of 1,400 households, BLS said Wisconsin's seasonally adjusted unemployment rate for January was 6.9 percent, down from a revised 7.0 percent in December 2011 and 7.7 percent in January 2011.

The unemployment rates encompass Wisconsinites who are available for work and actively seeking jobs and are generated by BLS from Wisconsin household surveys and other input.

The U.S. seasonally adjusted unemployment rate was 8.3 percent, down from 8.5 percent in December 2011 and down from 9.1 percent in January 2011.

Wisconsin unemployment rates remain below the national rates and, through December 2011, below rates of other major manufacturing Midwest states including Illinois, Indiana, Michigan and Ohio.

The BLS place of residence data also estimated that more people are working and fewer are unemployed, when comparing data either month to month or year to year. The over-the-year comparison shows an estimated 11,700 more people employed, and a 26,700 decrease in those unemployed. The corresponding over-the-month estimates show 1,600 more people employed, and 3,300 fewer unemployed.

## **Place of Work Data**

Based on a monthly survey of employers, preliminary seasonally adjusted data show a gain of 15,700 in private sector jobs from December 2011 to January of this year. Sectors with job growth and their one-month gains were: construction, 4,200; manufacturing, 3,700; professional and business services, 3,600; leisure and hospitality, 3,300, and retail trade, 2,200. Total non-farm job growth was 12,500 for the same one-month period, reflecting a 3,200 decrease in government jobs.

Seasonally adjusted data also show that, compared to January 2011, the private sector had a net gain of 900 jobs. Within the mix of gains and losses, the manufacturing sector had year-to-year job growth of 8,900. Total nonfarm employment was down 12,500, and government employment, down 13,400 jobs. ## 2011 Benchmark Revisions

Today's release of data also includes revised 2010 and 2011 monthly job totals that are "benchmarked," or adjusted by the BLS based on the availability of additional data. Data for place of residence data undergo benchmarking as well.

Job estimates for the last six months of 2010 and the first six months of 2011 have been revised to reflect the most recent Quarterly Census of Employment and Wages (QCEW) data available. Data for the latter months of 2011 have been revised to be consistent with QCEW data, but will not be benchmarked by the BLS until March 2013. In addition, seasonally adjusted months have been revised to reflect updated estimates of seasonal patterns.
