Intern Conduct Guidelines

Professionalism:

Treat everyone you encounter with respect and courtesy, from the Representative and your coworkers to office guests and constituents. Your behavior reflects upon Representative Neubauer, and they will judge her by your conduct.

Timeliness:

Arrive at the office or log on to the legislative network on time and ready to work. If you will be more than ten minutes late or will miss the day altogether due to sickness, school requirements, or another emergency, please notify the office as soon as possible. If you will not be able to follow your regular schedule, please give the office a call or an email so we are aware and can make alternate arrangements. Consistent tardiness or absenteeism may result in termination of your internship.

Privacy Agreement:

When assisting constituents, there will be times when you need to receive private information from them, such as addresses and phone numbers, or medical histories. All of this information is confidential and should not be shared with anyone outside the office.

Social Media:

As an intern, you should portray yourself in an appropriate manner on social media web sites such as Facebook, Instagram, and Twitter. This is especially important, but not exclusive to, when mentioning anything about the office.

Dress Code:

Dress in the office is business casual. On days when the Assembly is in session, dress should be more formal – plan on a jacket or blazer. Use your best judgment, and always err on the side of being professional. When not in session, dark jeans may be worn on Fridays provided they are not "distressed" (i.e., have no holes/rips).

When a member of the public requests to look at email, for instance, or the websites you have been visiting, it is necessary for the office to comply. This includes any email that you may open in your personal email accounts. If you do not want an email communication, instant message, etc., to be public record, please do not open it on the office computer.

Testifying at a Public Hearing:

We encourage civic engagement; however, if you choose to register on a bill and/or testify at a public hearing please make sure that you do so as a citizen of Wisconsin only. Please do not testify in representation of Representative Neubauer's office.
