

## State of Misconsin 2017 - 2018 LEGISLATURE

## **PRELIMINARY DRAFT - NOT READY FOR INTRODUCTION**

AN ACT to create 20.455 (2) (cm) and 165.984 of the statutes; relating to: creating a law enforcement agency drug crime response grant program and making an appropriation.

## Analysis by the Legislative Reference Bureau

This bill creates a grant program for Wisconsin law enforcement agencies to obtain funds to respond to drug crimes. Under the bill, any Wisconsin law enforcement agency may apply for a grant to fund law enforcement response to drug trafficking and drug use. To fund this grant program, the bill creates a general purpose revenue appropriation of \$1,000,000 in the 2017-19 biennium.

Notwithstanding s. 227.10 (1), the department need not promulgate the 20required policies and procedures as rules under ch. 227. 21(3) A Wisconsin law enforcement agency may apply to the department of justice 22for a grant under this section and shall include a proposed plan of expenditure of the 23grant money. If the proposed plan of expenditure will result in the agency incurring

an ongoing expense that will continue after all grant funds have been spent, the plan

shall include a description of how that expense will be met when there are no
 remaining grant funds.

3 (4) The department of justice shall review each application and plan and may
4 provide grants to an eligible Wisconsin law enforcement agency of not more than
5 \$50,000 per application and plan and not more than \$100,000 per Wisconsin law
6 enforcement agency.

7 (5) A Wisconsin law enforcement agency receiving a grant under this section
8 may use the grant to fund extra training for law enforcement officers, the hiring of
9 additional officers to investigate drug crimes, or any other purpose that is directly
10 related to drug crime response.
