

This Actuarial Audit update is submitted on behalf of the Board of Governors of the Injured Patients and Families Compensation Fund (Fund) as required by Legislative Audit Bureau Report 16-4, page 11, dated March, 2016.

The Office of the Commissioner of Insurance has procured the firm of Willis Towers Watson through the State of Wisconsin simplified bid process to perform this engagement. Willis Towers Watson commenced the audit on September 20, 2016 and will be reviewing the work papers of Pinnacle Actuarial Services, Inc. (Pinnacle) dated September 30, 2015.

The focus of the audit will be reviewing actuarial methods used by Pinnacle and specifically looking at the reasonableness of the recommended target range for the Fund's net position.

The Office of the Commissioner of Insurance expects the actuarial audit to be completed by December 1, 2016 for review by the Fund's appropriate committees and the Board of Governors.
