2015 Annual Operations Report

The Read to Lead Development Council met a total of three times in 2015. The dates and topics covered include:

1. January 30, 2015

• The Council reviewed and discussed the six-month status reports submitted by the first round of grant recipients; the use of funds from the State Farm® grant provided to the Read to Lead Development Council; and, the revised scoring process to be used for the second round of grant applications.

2. March 13, 2015

• In the second meeting, the Council identified six of the 126 applications submitted to be considered by the Governor and State Superintendent Evers (Table 1). The Council also discussed the proposed transfer to the Department of Children and Families (DCF) in the Governor's Biennial Budget.

3. October 22, 2015

This was the first Council meeting after transferring to DCF. The Council discussed the one-year
progress reports submitted by the first round of grant recipients and shared their vision of how
the Council should move forward.

On May 27, 2015, Governor Walker and State Superintendent Evers announced the six recipients of the Read to Lead Development Fund grants.

The Legislative Audit Bureau (LAB) released the third annual report on October 21, 2015. The report recommended that DCF work with the Read to Lead Development Council to include information on the Council's plans for awarding grants in the future and for raising private funds in its next annual report; and, to submit a copy of the report to the Joint Legislative Audit Committee by February 1, 2016.

The LAB report indicates the fund balance was \$283,303 at the end of FY 2014-15. However, \$173,895 is committed to expenditures incurred in FY 2015-16 as grant award recipients seek reimbursement for grant-related costs. After consideration of the committed funds, the available fund balance was \$109,408 (Table 2). The 2015-17 biennial budget provides the base \$23,600 annual appropriation and the Fund has not received any donations that could be utilized for grant awards since its inception.

As identified in Budget Paper #340, submitted to the Joint Committee on Finance on May 5, 2015, the Council faces a series of restrictions that limit the ability of the Council and its members to solicit donations; while current state ethics and lobbying laws also prohibit state officials from soliciting contributions.

At the October 22, 2015 Read to Lead Development Council meeting, members decided to indefinitely postpone awarding additional grants and requested that the Secretary identify how the Council can contribute to DCF in a meaningful way.
