1 **AN ACT** *to amend* 20.235 (1) (b), (fe), (ff), (fg) and (km), 20.285 (4) (dd), 20.505 (8)
2 (hm) 10., 36.34 (1) (c) 2. (intro.), 36.34 (1) (c) 2. am., 36.34 (1) (c) 2. b., 39.435 (7)
3 (b) (intro.), 39.435 (7) (b) 2. and 39.435 (7) (b) 2m.; and **to create** 36.34 (1) (c) 2.
4 ag., 36.34 (1) (c) 2. ar., 39.30 (5), 39.435 (7) (a) 3., 39.435 (7) (a) 4., 5. and 6.,
5 39.435 (7) (b) 1g. and 1r., 39.435 (7) (c) and (d) and 39.44 (6) of the statutes;
6 **relating to:** the Wisconsin higher education grant program, tuition grant program,
7 Lawton minority undergraduate grant program, minority undergraduate retention
8 grant program, and making appropriations.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

JOINT LEGISLATIVE COUNCIL PREFATORY NOTE: This bill draft was prepared for the Joint Legislative Council’s Special Committee on Review of Higher Education Financial Aid Programs.

The draft amends appropriations for various higher education grant programs to make the appropriations sum sufficient rather than sum certain amounts beginning in the 2011–12 state fiscal biennium. Namely, it amends the appropriations for higher education grants awarded to Wisconsin residents enrolled in the University of Wisconsin (UW) System, a technical college, or a tribal college; tuition grants awarded to Wisconsin residents enrolled in accredited, nonprofit institutions; Lawton grants awarded to minority undergraduates enrolled in the UW System; and minority undergraduate retention grants awarded to minority undergraduate students enrolled at least half–time in independent, technical, and tribal institutions in the state.

Under the draft, the sum sufficient appropriations would equal the amount appropriated for those grants in the previous fiscal year (base amount), increased by the average percentage by which the undergraduate academic fees for the next academic year are estimated to exceed those charged during the current academic year.

9 **SECTION 1.** 20.235 (1) (b), (fe), (ff), (fg) and (km) of the statutes are amended to read:

1 20.235 (1) (b) *Tuition grants.* ~~Biennially, the amounts in the schedule~~ A sum sufficient
2 equal to the amount calculated under s. 39.30 (5) for the purposes of s. 39.30.

3 (fe) *Wisconsin higher education grants; University of Wisconsin System students.* A
4 sum sufficient equal to \$37,750,000 in the 2009–10 fiscal year, equal to \$58,345,400 in the
5 2010–11 fiscal year, ~~and equal to the amount calculated under s. 39.435 (7) (b)~~ for the
6 Wisconsin higher education grant program under s. 39.435 for University of Wisconsin
7 System students, except for grants awarded under s. 39.435 (2) or (5), thereafter.

8 (ff) *Wisconsin higher education grants; technical college students.* ~~Biennially, the~~
9 ~~amounts in the schedule~~ A sum sufficient equal to the amount calculated under s. 39.435 (7)
10 (c) for the Wisconsin higher education grant program under s. 39.435 for technical college
11 students, except for grants awarded under s. 39.435 (2) or (5).

12 (fg) *Minority undergraduate retention grants program.* ~~Biennially, the amounts in the~~
13 ~~schedule~~ A sum sufficient equal to the amount calculated under s. 39.44 (6) for the minority
14 undergraduate retention grant program under s. 39.44.

15 (km) *Wisconsin higher education grants; tribal college students.* ~~Biennially, the~~
16 ~~amounts in the schedule~~ A sum sufficient equal to the amount calculated under s. 39.435 (7)
17 (d) for the Wisconsin higher education grant program under s. 39.435 for tribal college
18 students, except for grants awarded under s. 39.435 (2) or (5). All moneys transferred from
19 the appropriation account under s. 20.505 (8) (hm) 10. shall be credited to this appropriation
20 account. Notwithstanding s. 20.001 (3) (b), the unencumbered balance on June 30 of each
21 odd-numbered year shall revert to the appropriation account under s. 20.505 (8) (hm).

NOTE: This SECTION amends appropriations for the Wisconsin higher education grants, Wisconsin tuition grants, and minority undergraduate retention grants to make the appropriations sum sufficient rather than sum certain.

1 **SECTION 2.** 20.285 (4) (dd) of the statutes is amended to read:

NOTE: This SECTION amends the appropriation for the Lawton minority

appropriation for Wisconsin higher education grants for tribal college
students from Indian gaming receipts shall be calculated by the higher
educational aids board (HEAB) in the manner specified under a new
paragraph created in SECTION 16.
