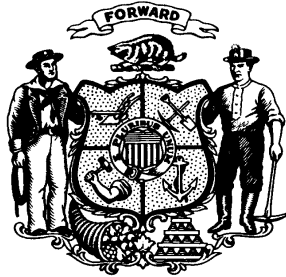

The Joint Legislative Council will be considering the report of the Special Committee on Local Service Consolidation on **Wednesday, May 4, 2011, in Room 412 East (the Joint Finance Room), State Capitol, Madison.** The meeting is scheduled to begin at 8:30 a.m. An agenda is enclosed for your reference.

4. **LRB-0654/1**, relating to loans to study or implement the consolidation, or cooperation for the provision, of local governmental unit services or the consolidation of local governmental units, and granting rule-making authority.
5. **WLC: 0075/1**, relating to exceptions to county and municipal levy limits and school district revenue limits for expenditures related to the implementation of service consolidation or cooperation, or to the implementation of political subdivision or school district consolidation.
