15.145(1)	16	Parole Commission in the Department of Corrections. Two members added to the commission.
15.157(3)	16	Dwelling Code Council in the Department of Commerce. One member added to represent remodeling contractors who are actively engaged in remodeling one- and two-family housing.
15.157(8)	16	Rural Health Development Council in the Department of Commerce. Two members added, one each to represent licensed dentists and licensed dental hygienists.
15.195(4)(e)	79	Child Abuse and Neglect Prevention Board attached to the Department of Health and Family Services under s. 15.03. Membership revised to allow legislators appointed to the board to designate others to serve in their place.
15.195(5)	16	Adolescent Pregnancy Prevention and Pregnancy Services Board , formerly attached to the Department of Health and Family Services, renumbered to s. 15.105(11) and attached to the Department of Administration under s. 15.03.
15.197(11n)	59	Council on Developmental Disabilities attached to the Department of Health and Family Services under s. 15.03. Membership revised to bring the council's makeup into conformity with federal law.
15.225(2)(b)	16	Wisconsin Conservation Corps Board attached to the Department of Workforce Development under s. 15.03. Membership revised to specify that the one member from a local workforce development board may be either a board member or employee of that board.
15.225(3)(b)6	16	Governor's Work-Based Learning Board in the Department of Workforce Development. Membership revised to allow the governor to designate the division administrator from the department who will serve on the board, replacing the requirement that the administrator of the repealed Division of Workforce Excellence be the board member.

15.373(2)	48	Division for Libraries and Community Learning in the Department of Public Instruction. Renamed Division for Libraries, Technology, and Community Learning .
15.405(7c)	80	Examining Board of Social Workers, Marriage and Family Therapists and Professional Counselors in the Department of Regulation and Licensing. Renamed Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board . Qualifications of professional members revised to reflect changes in credentialing by amending "certified" social workers to "certified or licensed" social workers and changing "certified" to "licensed" for the categories of marriage and family therapists as well as professional counselors.
15.406(1)	70	Physical Therapists Affiliated Credentialing Board in the Department of Regulation and Licensing. Membership revised to add one licensed physical therapist assistant in Section 15.406(1)(am).
15.497(2)	21	Council on Veterans Programs in the Department of Veterans Affairs. One member added to represent the Wisconsin chapter of the Paralyzed Veterans of America in Section 15.497(2)(d).
15.915(6)(b)	16	Environment Education Board attached to the University of Wisconsin under s. 15.03. Membership revised to add two members, one representing forestry and the second representing the energy industry.
