PROFILE OF THE 2005 WISCONSIN LEGISLATURE

January 3, 2005

This brief profiles the members of the 2005 Wisconsin Legislature at the time of their inauguration on January 3, 2005. It includes information about party affiliation, marital status, legislative experience, occupation, gender, age, educational background, and military service.

A summary table that offers comparable data for the last six legislatures is included. Similar information, dating back to the 1943 Legislature, has appeared in the *Wisconsin Blue Book* since 1956.

THE SENATE PROFILE

The senate has 33 members. When the 2005 Legislature convened on January 3, 2005, there were 19 Republicans and 14 Democrats. Of the total, eight senators were women and two were African-American. Twenty-three senators were married.

Legislative Experience. Of the 16 seats up for election in 2004, 11 members from the 2003 Senate were reelected, one incumbent senator was defeated, and four ran for open seats. Seventeen members were holdover senators in the middle of their terms.

A total of 23 senators have previous service in the assembly. In terms of combined prior service in both the senate and the assembly, 9 senators have served in 10 or more biennial sessions; 12 served in 5-9 sessions; and the remaining 12 have served in fewer than 5 sessions. Most notable is Senator Fred Risser (D-26th District), who has the distinction of the longest legislative tenure in Wisconsin state history with 21 prior sessions in the senate and three in the assembly for a total of 48 years of service.

Four senators had previous experience in a legislative staff position. One served on the staff of a member of Congress and the other three

worked for either a state senator or representative.

Local Government Experience. Fourteen senators have had experience in local government as elected public officials. Four served as county board supervisors and, of these, one was also an alderman. Three additional senators served on city councils, two were on school boards, four were on a town board, and one was both a town official and a school board member.

Age. As of January 3, 2005, the average age of a senator was 52 with an age range from 34 to 77 years. The age ranges for the senators were: 4 senators in the 30-39 range; 9 in the 40-49 range; 12 in the 50-59 range; and 8 senators over 60 years of age.

Occupation. Eleven senators list themselves as full-time legislators. One of these also lists the additional occupation of journeyman bricklayer. Two senators are currently practicing attorneys. Other current occupations include newspaper publisher, home builder, printer, farm management, raising exotic animals, owner of a baseball team, and nursing. One senator is a former fire chief.

Education. Of the 29 senators who continued their formal education beyond high school, 26 have academic degrees and three attended either a technical school or a college or university. Three senators hold law degrees, five have master's degrees, and 17 others hold bachelor's degrees. One has an associate degree.

Military Service. Nine senators have served in the nation's armed forces: one in each of the four major branches of service, three in the Army Reserve, one in the Marine Corps Reserve, and one in the Wisconsin Air National Guard. One senator is a veteran of World War II and three are Vietnam War veterans.

THE ASSEMBLY PROFILE

There are 99 representatives to the assembly. When the 2005 Legislature convened on January 3, 2005, there were 60 Republicans and 39 Democrats. Twenty-six members were women, a decrease of one from the 2003 session. Six representatives were African-American and one was Hispanic. Seventy representatives were married.

Legislative Experience. Eighty representatives were reelected in 2004, while 18 are serving their first term in the assembly. One new representative, Frederick P. Kessler (D-12th District), returns to the assembly after an absence of 32 years. Three incumbents were defeated in 2004: two in the general election and one in the primary. The other 16 new members did not face an incumbent. The longest-serving representative is Representative Marlin Schneider (D-72nd District), who has served in 17 prior sessions, for a total of 34 years. With the beginning of the 2005 session, Representative Schneider became the longest-serving representative in the history of the assembly. Other representatives with 10 or more prior sessions include one with 13, one with 12, two with 11, and three with 10. Other returning representatives include 24 with 5-9 sessions, 6 with 4 sessions, 15 with 3 sessions, 10 with 2 sessions, and 17 with one session.

Sixteen representatives have had previous experience in a legislative staff position. Three worked for a member of the U.S. Congress, 13 worked in the state legislature, and two worked for a member of Congress and a legislator.

Local Government Experience. Of the 41 representatives who have had experience in local elected office, five held office at both the county and municipal level, 13 others held county office, and an additional 23 had municipal service.

Eighteen representatives have served as county board supervisors, 14 as city council members, five as town board members, and three others were village trustees. Seven have served as school board members. Three were city mayors.

Age. As of January 3, 2005, the average age of a representative was 50 with an age range from 28 to 77 years. The age ranges for the representatives were: 3 in the 20-29 range; 15 in the 30-39 range; 30 in the 40-49 range; 37 in the 50-59 range; 9 in the 60-69 range; and 5 over 70 years of age.

Occupation. Thirty-nine representatives list themselves as full-time legislators (including four members who list additional occupations as attorney, veterinarian, physician, and supper-club owner). Nine representatives are currently farmers. Eleven representatives are currently practicing attorneys. Among the other representatives, thirteen list themselves as small business owners. Four are in the restaurant business. Two are physicians. Other current occupations include: realtor or real estate broker; farm manager; civil engineer; labor arbitrator; and registered nurse. Former occupations listed include 15 teachers, four farmers, and two restaurant owners.

Education. Of the 90 representatives who have continued their formal education beyond high school, 70 hold academic degrees, and 20 attended a college or university or an agricultural, business, technical, or trade school after high school graduation. Listed by their highest degree, two have an M.D. degree and 11 hold law degrees. One is a Doctor of Veterinary Medicine. Twenty-one others hold master's degrees. An additional 33 have bachelor's degrees. Two hold an associate degree.

Military Service. Nineteen representatives have served in the armed forces. Six served in the Army, three in the Air Force, and five in the Navy. Six were members of the Wisconsin National Guard, the Wisconsin Air National Guard, or the U.S. Army Reserve. Two of the Navy veterans later served in the U.S. Naval Reserve. One representative is a veteran of World War II and 11 are Vietnam War veterans. One representative served in Operations Desert Shield and Desert Storm, and one in Operation Iraqi Freedom.
