In response to the increases number of cases and hospitalizations being seen throughout Wisconsin, today Governor Tony Evers issued Emergency Order #3, limiting public indoor public gatherings to 25% of a room or building total capacity. A Frequently Asked Questions document on the order can be found here.

Our state is currently in a crisis, and has become the national hotspot for transmission of COVID-19. Our 7 day average of new daily cases is at 2,346, up from 836 just one month ago. Some hospitals have been forced to use waitlists or transfer patients to other facilities for treatment due to capacity constraints.

Limiting indoor gatherings is one of the most effective ways at reducing transmission, along with diligent hygiene, face coverings, and general physical distancing.

Statewide Mask Mandate Faces Legal Challenge

a St. Croix County Judge Michael Waterman has heard a case challenging the Governor's declaration of a public health emergency brought by the conservative Wisconsin Institute for Law and Liberty (WILL). The motion seeks to halt enforcement of the public emergency declarations, including the mask mandate, and would potentially include today's limits on indoor gatherings.

One of the statements the judge made that could indicate his thoughts on the matter was:

"They're asking the third branch of government — the judiciary — to step in and exercise a power that the Legislature reserved to itself. The court is being asked to do that when the Legislature has apparently chosen for one reason or another not to act."

Neither the state Senate nor the state Assembly have been given any indication that they will convene in order to pass a resolution ending the emergency declaration, or any other measures that would be aimed at helping the people of Wisconsin cope with the health and economic impact of the pandemic.

Miller Park and Fiserv Forum will no longer be Available for Early Voting

Milwaukee Election Commission Executive Director Claire Woodall-Vogg explained that potential legal challenges from the Republican Party of Wisconsin and a statement from the Wisconsin Elections Commission could possibly jeopardize any votes that might be cast from the two locations:

Recently, the Wisconsin Elections Commission issued a notice clarifying that alternate or additional sites for absentee voting had to have been designated by June, while the Miller Park and Fiserv Forum options had been announced in August.

"Unfortunately, the addition of these two sites could be legally challenged due to a recent court ruling, and we don't want to do anything that could risk a City of Milwaukee voter's ballot being counted," said Claire Woodall-Vogg. "We want residents of Milwaukee to feel complete and unwavering confidence that their ballot will be counted in the election and this action reflects that commitment."

Repeal of Prevailing Wage doesn't Live Up to Promised Results

A new study form the Midwest Economic Policy Institute found that repealing the prevailing wage had no noticeable effect on the cost of construction projects, and there was actually a drop in the number of bids for projects from local companies. The lawmakers who pushed for this policy promised that it would do the opposite.

What it did do, was lower wages for workers, while increasing them for CEOs, and bids from out-of-state contractors increased from 9 percent to 13 percent.

"What that means is ... Wisconsin tax dollars that previously went to Wisconsin contractors and construction workers, (are) now being used to pay workers from out of state," said Duncan, a member of the study's research team. "When that happens, Wisconsin tax money leaks out of Wisconsin and it stimulates economies in neighboring states instead of supporting the local economy."
