SUBJECT: Non-Fiscal Policy Items Contained Within the Governor's 2015-17 Budget Bill

This office has prepared the attached list of items that are contained within 2015 Assembly Bill 21/Senate Bill 21 (the Governor's 2015-17 budget recommendations). The list is comprised of items that are primarily of a non-fiscal policy nature and not closely related to the state's fiscal programs for the next biennium. Included are the page and item number showing where the provisions are described in the Legislative Fiscal Bureau's summary of the Governor's budget.

Putting such a list together always requires some subjective judgment on which items should be identified. Arguments could be made to expand the list beyond what is presented here or to delete some items from it. However, in preparing the attached list, this office applied the same criteria that it has used in previous biennia when identifying provisions of the executive budget bill as non-fiscal policy items.

The criteria used are as follows: (1) generally, the item has no state fiscal effect; (2) if there is a state fiscal effect associated with an item, the policy implications of the provision outweigh any potential fiscal effect; (3) the item has been, or is, the subject of separate, non-budget legislation; (4) the item is one that typically would be reviewed by a standing committee of the Legislature; and (5) the provision could be accomplished without statutory directive, such as reports, studies, and audits. Items that typically are not included on the list are those that: (1) affect state program eligibility; (2) would generally be referred to the Joint Committee on Finance if introduced as separate legislation; and (3) address a reorganization or transfer of state government operations or functions.

There are four provisions of the budget which have not been included on the list but have policy implications which should be noted.

Drug Testing. There are items in the bill related to drug testing that could impact participation in BadgerCare Plus for childless adults, FoodShare employment and training, unemployment insurance, and certain programs administered by the Department of Children and

Families. Although there are policy issues related to drug testing, the items have not been included on the list because they potentially could affect eligibility for these programs.

Changes to Family Care, IRIS, and ADRCs. As evidenced by the number of individuals who testified at the Committee's public hearings on long-term care services, the provisions in the budget reflect significant policy issues and the potential impact that they might have on program participants. However, because they affect one of the state's major social service and fiscal programs, they have not been placed on the list.

UW System Authority. The creation of the UW System Authority represents a major reorganization of a state entity and is thus, not included on the list. There are, however, significant changes for the University, which, if not a part of the entire transformation to Authority status, would be included on the non-fiscal policy list. These include such items as statutory changes to, among other things, the UW's mission, tenure, governance, and sabbatical leave.

Sports and Entertainment District (Milwaukee Bucks). This item is not included on the list because of its significant fiscal effect (\$220 million of bonding and \$2.8 million of debt service in 2016-17). When the state addressed stadium financing in the past, these matters were not included in state budgets. Miller Park (1995 Act 56), Lambeau Field (1999 Act 167), and the Bradley Center Sports and Entertainment Corporation (1985 Act 26) were addressed by the Legislature outside of the state budget process.
