#### **CO-SPONSORSHIP MEMORANDUM**

**RE**: **Co-sponsorship of LRB-4241/1**: relating to grants related to preventing suicide by firearm and making an appropriation

DEADLINE: Wednesday, October 2, 2019 at 5:00 PM

This legislation is part of a broader package of bills recommended by the Speaker's Task Force on Suicide Prevention. This bipartisan task force was created in March of 2019 and held six public hearings across the state with the charge of evaluating the current resources for suicide prevention and identifying opportunities to target and assist at-risk individuals.

LRB-4241/1 is meant to bring mental health professionals and firearm retailers and ranges into the decision making process of preventing suicides. This bill is a way to de-stigmatize mental health by allowing individuals and their families to voluntarily store their firearms in a safe place while they get through their time in crisis. It also allows firearm ranges and retailers to become a part of the conversation on mental health and suicide.

The Gun Shop Project was first started by the New Hampshire Firearm Safety Coalition after three people, with no connection to each other, purchased a firearm from the same store and killed themselves. The medical examiner's office brought this to the attention of their mental health liaison, a small group of firearm retailers, and mental health/public health practitioners to explore whether there is a role for gun stores in preventing suicide. This is when the New Hampshire Firearm Safety Coalition was formed and its main goal is to bring mental health providers, firearm retailers, and firearm rights advocates together on ways they can

help prevent suicide. The project developed materials for firearm retailers and range owners on ways they can help prevent suicide.

The objectives are to: share guidelines on how to avoid selling or renting a firearm to a suicidal customer, encourage gun stores and firing ranges to display and distribute suicide prevention materials tailored to their customers. Currently, 12 states, including Wisconsin partake in this project in some way. Currently, Essential Shooting Supplies in Mt. Horeb, Wisconsin will store firearms for individuals, no questions asked, for a small fee of \$5 while the individual or family gets through their crisis.

This legislation will to take what the Gun Shop Project's initiatives were in New Hampshire and what some gun shop owners are doing in Wisconsin already, statewide. This bill directs the Department of Health Services to award grants to organizations for sharing guidelines and training staff at firearm retailers/firearm ranges on avoiding selling firearms to persons who may be considering suicide, providing materials relating to suicide prevention, and providing voluntary firearm storage.
