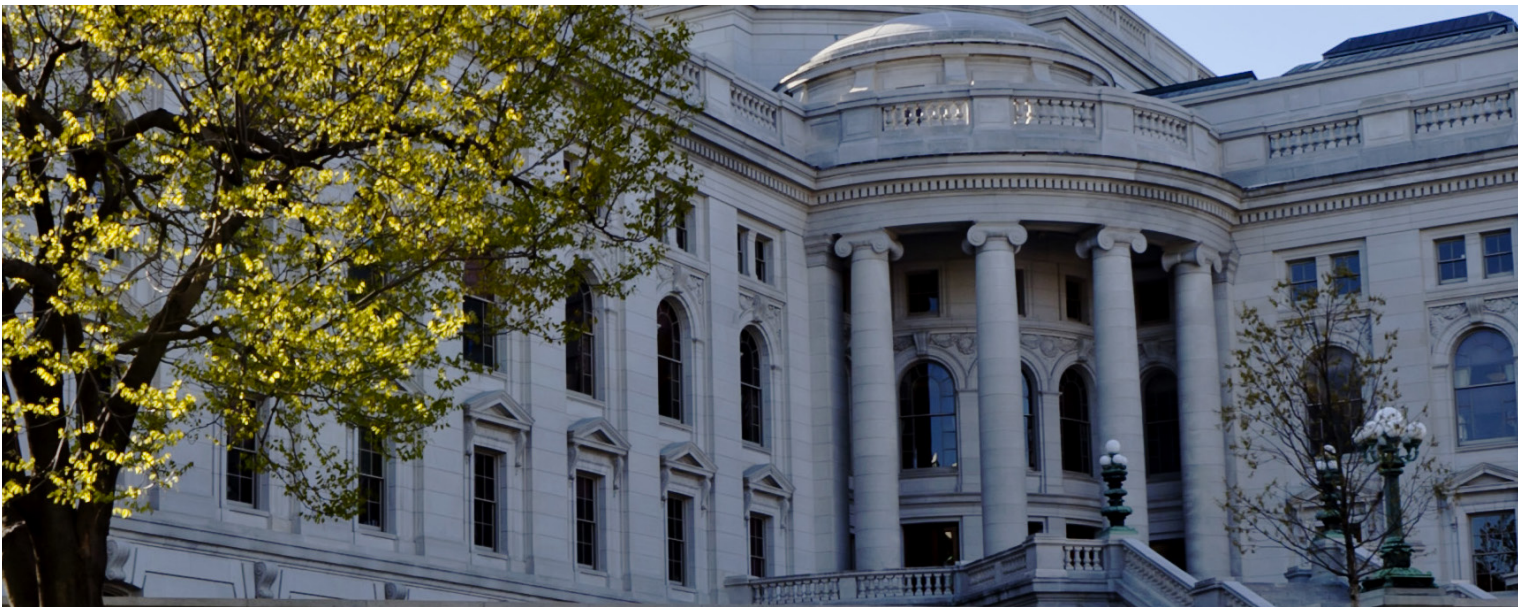

Dear Senator Cowles:

As requested by the Joint Legislative Audit Committee, we have completed a limited-scope review of how the Department of Administration (DOA) used supplemental federal funds provided in response to the public health emergency.

From March 2020 through June 2022, the Coronavirus Aid, Relief, and Economic Security (CARES) Act, the American Rescue Plan Act (ARPA), and the Consolidated Appropriations Act provided DOA \$5.7 billion in supplemental federal funds. DOA paid \$2.2 billion to other state agencies and spent \$1.5 billion on its own programs. As of June 30, 2022, \$1.9 billion was remaining.

Federal law provides the State with the discretion to spend \$4.5 billion of the \$5.7 billion in supplemental federal funds, but federal law requires that \$1.1 billion be spent for specified purposes, such as on particular programs that state agencies administer. As of June 30, 2022, \$1.8 billion in discretionary funds were remaining. In December 2022, DOA indicated it had plans for using most of these funds.

DOA did not provide us with information DOA indicated it and the Governor's Office had considered in deciding to use discretionary funds for the nine state programs that we selected for our review. However, DOA provided us with information on the planned use of the \$1.8 billion in remaining discretionary funds.

Federal law permits some supplemental federal funds to be spent through December 2026. DOA should increase the transparency and clarity of the State's use of supplemental federal funds, including by documenting how decisions were made to use discretionary funds for particular state programs. It should also include on its website additional information about supplemental federal funds, including plans for spending the remaining funds and how such plans change over time. Providing clear and comprehensive information will allow legislators and the public to more readily identify how these funds are spent in the future.

A response from DOA follows the appendix.

## Introduction

---

The federal government annually provides the State with federal funds for various programs administered by state agencies, such as the Department of Transportation's state highway program. Since March 2020, the federal government has also provided supplemental federal funds to help Wisconsin respond to and recover from the public health emergency. The federal government provided a portion of these supplemental federal funds to the Department of Administration (DOA), which paid funds to other state agencies for programs they administered and spent funds on its own programs. In addition, the federal government provided supplemental federal funds directly to state agencies other than DOA, such as \$2.4 billion provided to the Department of Public Instruction for the Elementary and Secondary School Emergency Education Relief Fund that helps local educational agencies prepare for and respond to the public health emergency.

Table 1 shows the different types of federal funds provided to the State, including \$5.7 billion in supplemental federal funds provided to DOA from March 2020 through June 2022. This limited-scope review focuses on this \$5.7 billion, which includes funds DOA paid to other state agencies, funds DOA spent on its own programs, and funds that were remaining as of June 30, 2022. DOA had not paid these remaining funds to other state agencies or spent them on its own programs. Federal law permits some of these funds to be spent through December 2026.

***Three federal acts provided DOA the \$5.7 billion in supplemental federal funds.***

As shown in Table 2, three federal acts provided DOA the \$5.7 billion in supplemental federal funds, including the:

- Coronavirus Aid, Relief, and Economic Security (CARES) Act, which was passed in March 2020 and provided funds to support K-12 and higher education, unemployment benefits, and transit, including funds provided through the Coronavirus Relief Fund;
- Consolidated Appropriations Act, which was passed in December 2020 and provided additional support for state programs funded by the CARES Act, as well as for the emergency rental assistance program and other newly created programs; and
- American Rescue Plan Act (ARPA), which was passed in March 2021 and provided funds to support education, health, and transportation, including Coronavirus State and Local Fiscal Recovery Funds.

*To the extent that certain programs incur eligible expenditures that are reimbursed after June 2022, additional supplemental federal funds beyond the \$5.7 billion will be provided.*

In some instances, the federal acts support programs for which the State is reimbursed after eligible expenditures are incurred. For example, DOA was reimbursed with CARES Act funds after its Emergency Solutions Grant program incurred eligible expenditures. This limited-scope review includes the amounts reimbursed to DOA through June 2022. To the extent that certain programs incur eligible expenditures that are reimbursed after June 2022, additional supplemental federal funds beyond the \$5.7 billion will be provided.

Questions have been raised about how decisions were made to use the supplemental federal funds provided to DOA for particular state programs. Questions have also been raised about plans to spend the remaining funds.

To complete this limited-scope review of the \$5.7 billion in supplemental federal funds provided to DOA, we contacted DOA and analyzed information in the State's accounting system. To assess how decisions were made to use funds for particular state programs, we requested that DOA provide us with relevant information for nine state programs administered by DOA or other state agencies. This limited-scope review does not determine how state agencies spent the supplemental federal funds that DOA paid to them or whether DOA and other state agencies spent these funds appropriately.

## Supplemental Federal Funds

---

We assessed the \$5.7 billion in supplemental federal funds provided to DOA from March 2020 through June 2022. We determined the state agencies to which DOA paid a portion of the funds and categorized the types of programs supported by these funds. We also categorized the types of DOA-administered programs on which DOA spent a portion of the funds. The appendix provides information about the state programs supported by the funds. In addition, we determined the total amount of supplemental federal funds that remained as of June 30, 2022.

### Amount of Funds

***From March 2020 through June 2022, DOA paid \$2.2 billion in supplemental federal funds to other state agencies and spent \$1.5 billion on its own programs.***

As shown in Table 3, DOA paid \$2.2 billion in supplemental federal funds to other state agencies and spent \$1.5 billion on its own programs from March 2020 through June 2022. The amount DOA spent on its own programs includes \$163.2 million that the federal government originally provided for DOA's Emergency Rental Assistance program but that DOA transferred, with approval from the U.S. Department of Treasury, in January 2022 to five local governments that operate their own emergency rental assistance programs. We discussed this transfer in our May 2022 audit of Emergency Rental Assistance and Emergency Solutions Grant Programs (report 22-3). As of June 30, 2022, \$1.9 billion in supplemental federal funds was remaining.

### Funds DOA Paid to Other State Agencies

***DOA paid a total of \$1.8 billion in supplemental federal funds to the departments of Revenue and Health Services from March 2020 through June 2022.***

Table 4 shows the 10 state agencies to which DOA paid the most supplemental federal funds from March 2020 through June 2022. DOA paid a total of \$1.8 billion to the departments of Revenue and Health Services, which was 79.4 percent of the total amount it paid to all state agencies. DOA required state agencies to use the funds to support a variety of programs.

We used information in the State's accounting system to categorize the types of programs supported by the supplemental federal funds that DOA paid to other state agencies. These categories included:

- small business recovery grants, such as \$303.2 million for the Wisconsin Tomorrow program through which the Department of Revenue awarded grants to small businesses;
- public health emergency supplies and response, such as \$156.5 million for the Provider Payment Program through which the Department of Health Services awarded grants to home and community-based service providers, assisted living facilities, and nursing homes in order to offset public health emergency-related expenditures;
- local government recovery grants, such as \$411.4 million in Local Fiscal Recovery Funds that the Department of Revenue was required to transfer to local governments;

- industry and tourism assistance, such as \$100.0 million for the Wisconsin Farm Support program through which the departments of Agriculture, Trade and Consumer Protection and Revenue awarded grants to farmers that suffered economic damages as a result of the public health emergency;
- other purposes, such as \$67.4 million for staffing and other resources for the Department of Workforce Development's unemployment insurance systems;
- childcare and education assistance, such as \$79.5 million for the Child Care Counts program through which the Department of Children and Families awarded grants to childcare providers; and
- benefit programs for individuals, such as \$29.8 million for two Food Security grant programs through which the Department of Agriculture, Trade and Consumer Protection awarded grants to nonprofit organizations to fight food insecurity and support Wisconsin agricultural products, food banks, and consumers.

***DOA paid state agencies \$659.0 million for small business recovery grant programs from March 2020 through June 2022.***

As shown in Table 5, DOA paid state agencies \$659.0 million in supplemental federal funds for small business recovery grant programs and \$614.2 million for public health emergency supplies and response programs from March 2020 through June 2022. Combined, these two types of programs accounted for 57.4 percent of all funds that DOA paid to state agencies.

### Funds DOA Spent on Its Own Programs

We used information in the State's accounting system to categorize the types of DOA-administered programs on which DOA spent supplemental federal funds. These categories included:

- benefit programs for individuals, such as \$212.5 million for the Emergency Rental Assistance program through which DOA provided financial assistance to individuals who met certain income requirements and who owed rent and security deposits;
- public health emergency supplies and response, such as \$290.8 million for test kits and diagnostics;
- local government recovery grants, such as \$201.4 million for the Routes to Recovery program through which DOA awarded grants to local governments;
- childcare and education assistance, such as \$110.0 million for the School Aid Funding program that provided school districts and independent charter schools with \$134 per pupil;

- industry and tourism assistance, such as \$48.2 million for the COVID-19 Live Music and Entertainment Venue and the Live Event Small Business Assistance grant programs that awarded grants to various entities, including those that produced or presented live music;
- other purposes, such as \$5.0 million for state operations, emergency supplies, and other costs incurred during the public health emergency; and
- small business recovery grants, such as \$11,800 to help chambers of commerce and non-profit organizations provide assistance to small businesses.

***DOA spent \$468.7 million in supplemental federal funds on benefit programs for individuals from March 2020 through June 2022.***

As shown in Table 6, DOA spent \$468.7 million in supplemental federal funds on benefit programs for individuals as well as \$358.2 million on public health emergency supplies and response programs from March 2020 through June 2022. Combined, these two types of programs accounted for 54.3 percent of all such funds DOA spent on its own programs.

## Remaining Funds

As of June 30, 2022, \$1.9 billion in supplemental federal funds remained. Most remaining funds were provided through ARPA. However, \$1.6 million was provided through the Consolidated Appropriations Act, and \$0.2 million was provided through the CARES Act.

Through June 2022, a portion of the \$1.9 billion in remaining supplemental federal funds had been designated by DOA for specific programs and, therefore, cannot be spent on other programs. For example, DOA signed an agreement with the Public Service Commission in July 2021 to designate \$103.4 million in ARPA funds to administer a broadband expansion grant program. The Public Service Commission subsequently awarded \$99.9 million in grants to telecommunication providers to support projects to construct broadband infrastructure throughout the state, as we noted in report 22-11. These projects were ongoing at the time of our limited-scope review. To the extent that these providers request reimbursement for their actual project costs, the Public Service Commission will request the necessary funds from DOA. Doing so will reduce the \$1.9 billion in remaining funds. In December 2022, DOA indicated it had plans for using most of the remaining funds.

## Discretionary Funds

---

Federal law requires supplemental federal funds to be spent on purposes related to the public health emergency. Federal law provides the State with the discretion to spend \$4.5 billion of the \$5.7 billion in supplemental federal funds provided to DOA from March 2020 through June 2022. In contrast, federal law requires that \$1.1 billion be spent for specified purposes, such as on particular programs that state agencies administer. We asked DOA to provide us with information it and the Governor's Office had considered in deciding to use discretionary funds for nine state programs. DOA did not provide us with such information. As of June 30, 2022, \$1.8 billion in discretionary funds remained. DOA provided us with information on the planned use of these remaining discretionary funds.

### Amount of Funds

***Federal law prescribes how \$1.1 billion in supplemental federal funds provided to DOA must be spent.***

Federal law prescribes how \$1.1 billion in supplemental federal funds provided to DOA must be spent, including on programs DOA administered and programs other state agencies administered. For example, federal law provided \$434.7 million for DOA's Emergency Rental Assistance program, including \$322.2 million provided by the Consolidated Appropriations Act and \$112.5 million provided by ARPA. In contrast, federal law provides discretion in how most of the supplemental federal funds provided to DOA must be spent.

Statutes provide the Governor with the authority to decide how to spend discretionary federal funds provided to the State. Section 16.54, Wis. Stats., indicates that the Governor is authorized to accept federal funds provided to the State, other than funds designated for tribes. Chapter 20, Wis. Stats., indicates that all funds received from the federal

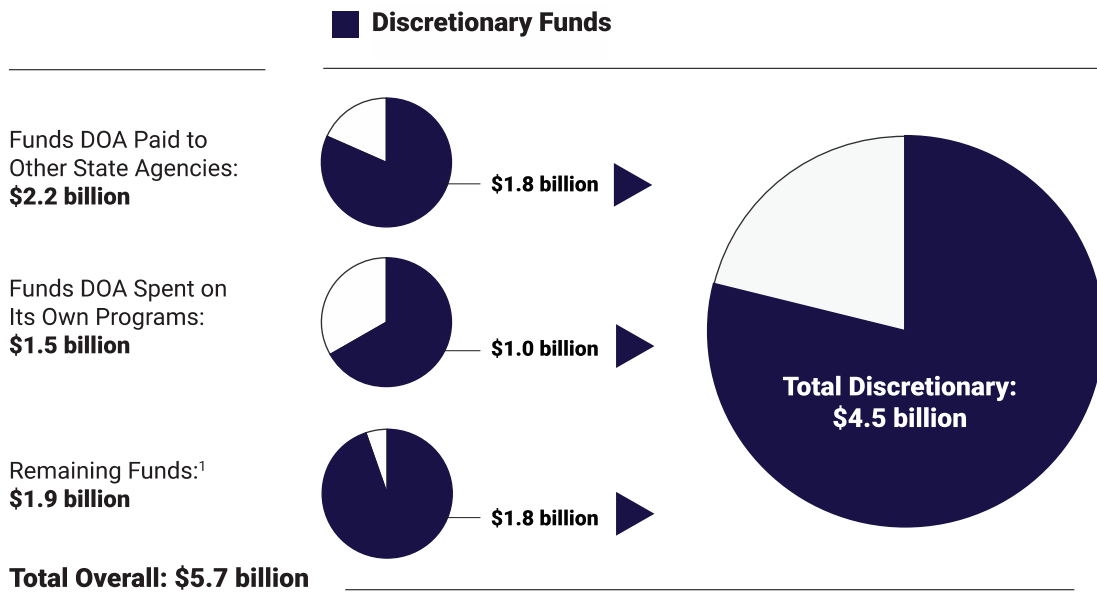
government, as authorized by the Governor under s. 16.54, Wis. Stats., are to be deposited into designated appropriations. These federal funds are spent without legislative input.

***The Governor has the discretion to use \$4.5 billion in supplemental federal funds provided to DOA.***

As shown in Figure 1, the Governor has the discretion to use \$4.5 billion in supplemental federal funds provided to DOA from March 2020 through June 2022. This amount includes \$1.8 billion that DOA paid to other state agencies and \$1.0 billion that DOA spent on its own programs.

As shown in Table 7, the CARES Act provided \$2.0 billion in discretionary funds and ARPA provided \$2.5 billion in discretionary funds to DOA from March 2020 through June 2022. The Consolidated Appropriations Act provided no discretionary funds.

## Funding Decisions

To decide how to use the discretionary funds for specific state programs, DOA indicated that individuals from the Governor's Office and DOA had relied on various sources of information, including:

- input from the public and organizations representing firms and other entities affected by the public health emergency;
- the Department of Revenue's tax data that indicate the extent to which business sectors suffered decreased revenue during the public health emergency;
- the Wisconsin Economic Development Corporation's knowledge about communities and businesses throughout the state; and
- relevant data from other state agencies.

DOA indicated the process for deciding how to use supplemental federal funds varied over time, depending on the particular issues and the state programs that were considered. However, DOA indicated the funds supported a broad range of individuals, firms, and organizations affected by the public health emergency.

We attempted to assess how decisions were made to use discretionary funds for particular state programs. To do so, we requested that DOA provide us with relevant information for nine state programs that we

selected based on factors such as the amounts of funds involved and the state agencies that administered these programs. The nine programs included four programs that DOA administered and five programs that other state agencies administered.

*We selected for our review nine state programs for which DOA used \$412.6 million in discretionary funds through June 2022.*

Table 8 shows the nine state programs we selected for our review. Press releases from the Governor’s Office and state agencies announced initially that \$795.0 million in discretionary funds would be provided to these nine programs. Information in the State’s accounting system indicated that the actual amounts used for these nine programs totaled \$412.6 million through June 2022. The actual amounts used for some programs exceeded the amounts that had been initially announced, and the actual amounts used for other programs were less than the amounts that had been initially announced. DOA indicated the changing effects of the public health emergency at times required it to adjust the amounts used for particular programs.

In May 2022, DOA described the process it and the Governor's Office had used to make funding decisions. Based on the description of this process and the information DOA indicated had been considered during meetings to decide how to use the discretionary funds, we requested that DOA provide us relevant documentation for the nine state programs. Our request included initial funding requests, agendas and minutes of the meetings that discussed the use of the funds, planning worksheets, one-page summary documents describing the use of the funds, and written approvals from the Governor's Office to use the funds. In response to our request, DOA provided us with publicly available information, such as press releases, links to state agency websites for the programs, and grant announcements for programs involving grants. DOA did not provide us with documentation of the process or the information DOA indicated it and the Governor's Office had considered in deciding to use discretionary funds for the nine state programs. In December 2022, DOA indicated that decisions for using the funds were made during daily conversations with the Governor's Office, rather than in written documents.

## Remaining Discretionary Funds

*As of June 30, 2022, \$1.8 billion in discretionary funds provided to DOA remained.*

As shown in Table 9, \$1.8 billion in discretionary funds provided to DOA remained as of June 30, 2022. Almost all of these funds were provided by ARPA. Federal law required all discretionary CARES Act funds to be spent by September 30, 2022, but it permits ARPA discretionary funds to be spent through December 31, 2026.

The Department of Treasury requires states to submit to it quarterly reports on the state programs supported by ARPA funds, such as program expenditures made during the most-recent quarter and the planned use of remaining funds. DOA and Treasury publish information from these quarterly reports on their websites.

We reviewed DOA's quarterly report for the period from April 2022 through June 2022. This quarterly report indicates the planned use of remaining ARPA funds to support state programs. Although this information was current as of late-June, the planned use of funds can change if the Governor's Office and DOA subsequently identify more-pressing needs for the remaining funds. For example, DOA provided information indicating it anticipated using \$37.4 million in remaining funds to support six new programs that had not been included in the quarterly report for April 2022 through June 2022. At the time of our review, DOA indicated it had not yet determined how the overall plans for using the remaining funds would change as a result of the decision to fund these six new programs.

We used information DOA provided to us to categorize the state programs that DOA planned, as of June 2022, to support with remaining ARPA discretionary funds. We categorized these programs according to the methodology we used to categorize state programs supported by the supplemental federal funds that DOA paid to state agencies or spent on its own programs.

***As of June 30, 2022, DOA planned to use \$392.2 million in remaining ARPA discretionary funds for local government recovery grant programs.***

As shown in Table 10, DOA planned as of June 30, 2022, to use \$392.2 million in remaining ARPA discretionary funds for local government recovery grant programs, which includes grants to Local and Tribal governments to help neighborhoods recover from the public health emergency. DOA reserved \$216.4 million to support the future costs of public health emergency response, recovery, and economic assistance activities.

## Increasing Transparency

---

***DOA should increase the transparency and clarity of the State's use of supplemental federal funds.***

DOA should increase the transparency and clarity of the State's use of supplemental federal funds. DOA should do so by documenting how decisions were made to use discretionary funds for particular state programs. It should also include on its website additional information about supplemental federal funds, including plans for spending the remaining funds and how such plans change over time. Providing clear and comprehensive information will allow legislators and the public to more readily identify how the remaining supplemental federal funds are spent in the future.

### **Documenting Funding Decisions**

As noted, DOA did not provide us with information DOA indicated it and the Governor's Office had considered in deciding to use discretionary funds for nine state programs that spent \$412.6 million in such funds through June 2022. Instead, DOA provided us with publicly available information, such as press releases that announced funding for the nine state programs we selected for our review.

***DOA should document how decisions were made to use discretionary funds for particular state programs.***

DOA should document how decisions were made to use discretionary funds for particular state programs. For each program, such documentation should include:

- the proposed use of the funds, including whether the funds will support a new or an existing program;
- an explanation of why the funds are needed for the program;

- the amount that will be used for the program;
- relevant information and data that were used to arrive at the funding decision and amount;
- the anticipated benefits of using the funds to support the program;
- the state agency that manages the program; and
- the anticipated date the funding decision will be reassessed and the factors that will be used to reassess it, such as the extent to which the funds are spent.

Documenting how decisions were made to use specific amounts of discretionary funds for particular state programs will increase transparency and clarity of funding decisions. Such documentation can also explain why initial funding decisions were subsequently modified, including because more-pressing needs for the funds were identified and because the federal government modified spending requirements after DOA had used the funds.

#### **Recommendation**

---

*We recommend the Department of Administration:*

- *document how decisions were made to use discretionary funds for particular state programs; and*
- *report to the Joint Legislative Audit Committee by February 17, 2023, on the status of its efforts to implement this recommendation.*

### **Reporting Additional Information**

Section 16.545 (3), Wis. Stats., requires DOA to establish a federal aids management service to advise the Governor and the Legislature of alternative and recommended methods of administering federal aid programs. Statutes require this service to conduct other activities, such as fully informing the Governor, the Legislature, state agencies, and the public about available federal aid programs and maintaining an information center on federal aid programs. DOA indicated it fulfills these requirements, in part, through ongoing discussions with the Legislative Fiscal Bureau, the Governor's Office, and state agencies, as well as by posting on its Badger Bounceback website information on how supplemental federal funds have been spent.

DOA reports information on how supplemental federal funds support particular state programs, including on its Badger Bounceback website and in quarterly and annual reports to the U.S. Department of Treasury on the use of ARPA funds. This information includes program descriptions and amounts spent. However, DOA does not publicly maintain a clear and comprehensive summary of its plans for spending the remaining funds and how such plans may have changed over time.

***DOA should include on its Badger Bounceback website additional information about supplemental federal funds.***

DOA should include on its Badger Bounceback website additional information about supplemental federal funds. Such reports should include all funds received through the CARES Act, the Consolidated Appropriations Act, and ARPA, as well as any additional federal acts that provide supplemental federal funds to DOA. The website should include information such as:

- the amount of funds that each federal act provided to DOA in the prior quarter and the total amount provided by each federal act to date;
- the amount of funds that DOA used for each state program during the prior quarter and the total amount that DOA used for each program to date, including programs administered by other state agencies and DOA;
- a brief description of each program, including the state agency that administered it;
- the amount of funds spent by each program during the prior quarter and the total amount spent by each program to date;
- any adjustment in the amount of funds previously used for a particular program, as well as a brief description of why such an adjustment was made;
- the total amounts of remaining funds at the end of a given quarter; and
- a summary of the planned use of funds in the next quarter, as well as a brief description of why the planned use may have changed since the last quarter.

Including additional information on the Badger Bounceback website will help to increase the transparency and clarity of how state agencies have spent and plan to spend supplemental federal funds. As noted, \$1.9 billion in such funds remained as of June 30, 2022. Including additional information on the website can also explain how and why plans for spending the funds change over time.

**Recommendation**

---

*We recommend the Department of Administration:*

- *include additional information on its Badger Bounceback website about supplemental federal funds, including plans for spending the remaining funds and how such plans change over time; and*
- *report to the Joint Legislative Audit Committee by February 17, 2023, on the status of its efforts to implement this recommendation.*

**Issue for Legislative Consideration**

*The Legislature could consider modifying statutes to periodically require DOA to report to it specific information about supplemental federal funds.*

The Legislature could consider modifying statutes to require DOA to periodically report to it specific information about supplemental federal funds. For example, the Legislature could require DOA to report information on the amount of such funds that the federal government provided in the prior quarter, how the funds were spent, and plans for spending the funds on particular state programs in the future. Such a reporting requirement could be developed by modifying the existing provisions in s. 16.545 (3), Wis. Stats.

On behalf of the Department of Administration (DOA), I would like to thank the Legislative Audit Bureau (LAB) for its evaluation of the supplemental federal funding being administered by DOA. DOA remains committed to our goal of quickly, carefully, and efficiently administering these funds to state agencies and third parties for high-impact initiatives that will achieve Governor Evers' vision for a Wisconsin that bounces back from the COVID-19 pandemic stronger than before.

LAB's report focuses on \$5.7 billion received by Wisconsin as of June 30, 2022, from the Coronavirus Aid, Relief, and Economic Security (CARES) Act, the American Rescue Plan Act (ARPA), and the Consolidated Appropriations Act. As summarized in the report, Governor Evers has authority to spend discretionary funds provided to the state by the federal government, and the Governor designated DOA as the administering agency over these funds. See s. 16.54 Wis. Stats.

DOA's administration of these funds has been crucial to the state's recovery from the COVID-19 pandemic and has played a part in putting the state in its best financial position ever. As the administering agency, DOA has worked to allocate and distribute an unprecedented amount of federal relief funds consistent with the Governor's directives by serving in administrative, coordination, and clearinghouse capacities to meet financial, reporting, legal, and compliance needs. The report affirms how the Governor is, through DOA, allocating these federal funds to invest in the areas key to our state's recovery: pandemic response and public health, workforce development and economic resilience, community building, education and childcare, individual assistance, and access to broadband.

The LAB's recommendations provided valuable assistance to the Department in recommending ways to improve documentation and transparency in its administration of these funds. The Department's responses to LAB's specific recommendations are set forth below in the order presented in the LAB's report.

**Page 26: Documentation of Decision-making**

DOA appreciates LAB's recommendation regarding improvement of its decision documentation and will plan to update the Joint Legislative Audit Committee (JLAC) on its efforts in this area by February 17, 2023.

The critical need for both expediency and responsiveness in administering these funds so that the state could meet evolving needs both from a public health and economic perspective lent itself to decision-making that took place largely through near-daily conversations with the Governor's Office and relevant agency partners. However, DOA did include information in what it provided to LAB regarding the policy underpinnings and need for programs and investments the Governor chose to fund—information that would have been relied upon in making such decisions. This information was present in the Memorandums of Understanding entered into between DOA and the implementing state agency, in the public documents created both to announce the various programs and investments and make them available to recipients, as well as in DOA's ongoing reporting to the U.S. Department of Treasury.

**Page 29: Include additional information on the Badger Bounceback Website**

DOA appreciates LAB's recommendation regarding making additional information available on the Badger Bounceback website and will plan to update JLAC on its efforts in this area by February 17, 2023.

The Badger Bounceback website includes a wealth of information for the public regarding the investments being made with certain supplemental federal funds. DOA notes that the investments included on the Badger Bounceback website already represent plans for the use of remaining funds in that typically the projects and initiatives are inclusive of the full allocation made by Governor Evers, even if the entire amount of funding has not yet been paid to the implementing agency or third party. In addition, the website also contains links to the quarterly and annual reports submitted by DOA to the U.S. Department of Treasury, which already contain the kinds of financial, narrative, and contextual information that LAB recommends documenting.

Thank you again for your time and consideration in completing this report. I appreciate the opportunity to comment on your recommendations.
