Rep. Callahan Statement on LGRF Relief Funding Deadline

35th Assembly District could lose out on \$3,624,358.05 in federal funding if municipalities miss Friday deadline

[**Madison, WI**] – About 1,200 Wisconsin municipalities are eligible to receive Local Government Recovery Funds (LGRF) through the American Rescue Plan Act (ARPA) and have not yet filed. The deadline is this **Friday, June 18, 2021**. Authorized uses of the funds are as follows:

- To support public health expenditures
- Address negative economic impacts caused by the public health emergency
- Replace lost public sector revenue
- Provide premium pay for essential workers
- Invest in water, sewer, and **broadband infrastructure**

Rep. Calvin Callahan (R-Tomahawk) made the following statement regarding the allocation of these funds:

“This funding could have a huge impact on many communities in the 35th Assembly District,” said Rep. Callahan. “In making calls to those who have not applied yet, the issue I’m hearing is that they simply aren’t aware that there is this pile of money up for grabs. I encourage any municipality in the district that has not yet applied, please do so as soon as possible. If you have any questions, please don’t hesitate to contact my office.”
