Omnibus Motion
[LFB Papers #145 thru #151]

Motion:

Move to adopt the following provisions:

1. *Tribal Gaming Appropriations and General Fund Revenue (LFB Paper #145)*. Re-estimate tribal gaming general fund revenue at \$2,038,600 in 2021-22 and \$25,255,300 in 2022-23 based on changes to estimated debt service payments.
 2. *Native American Assistance Grants (LFB Paper #146)*. Create a program to provide one-time grants to American Indian tribes or bands in Wisconsin, and provide \$7,000,000 PR in 2021-22, funded by tribal gaming revenues. Specify that the Department of Administration establish the amount of each grant based on the number of employees employed by the tribe or band as of December 31, 2019. Specify that each tribe or band may use grant moneys as it deems necessary to support programs to meet the needs of members of the tribe or band. Grant moneys may not be used to pay gaming-related expenses. Sunset the program on July 1, 2022.
 3. *Tribal Youth Wellness Center (LFB Paper #147)*. Modify Alternative 2 to provide \$350,000 PR annually on a one-time basis during the 2021-23 biennium from tribal gaming revenues to support the tribal youth wellness center. Modify the youth wellness center appropriation to repeal the limitation that funds may only be used to create architectural plans.
 4. *University of Wisconsin -- Green Bay Summer Camp (LFB Paper #150)*. Modify Alternative 1 to provide \$109,300 PR annually on a one-time basis during the 2021-23 biennium funded by tribal gaming revenues, to UW-Green Bay for educational summer camp programs developed in partnership with the Oneida Nation of Wisconsin.
 5. *Bingo and Raffle Appropriation (LFB Paper #151)*. Adopt Alternative 1 to combine the PR appropriations for raffle and bingo program operations. Specify that the unencumbered balance associated with bingo program operations be transferred to the lottery fund at the end of each fiscal year.
