Motion:

Move to adopt the following provisions:

Departmentwide

1. *Information Technology Consulting Services, Subscriptions, and* #676). Adopt Alternative A1 to provide \$546,000 annually to support the cost of maintain the services of 3.0 staff contracted to DSPS. Adopt Alternatives 2a, provide the following funding for agency subscription costs: (a) \$142,600 in 2026-27 for Salesforce Marketing Cloud software; (b) \$77,900 in 2025-26 and 2026-27 for HealthSpace software; (c) \$21,800 in 2025-26 and \$22,500 in 2026-27 for Center software; (d) \$13,500 in 2025-26 and \$14,700 in 2026-27 for the subscription; and (e) \$10,000 in 2025-26 and \$10,300 in 2026-27 for the service. Adopt Alternative 3 to provide one-time funding of \$149,400 in 2026-27 to maintain IT equipment for staff, including laptops, monitors, and

2. *Appropriation Consolidation (Paper #677)*. Adopt Alternative A1 to provide appropriations for the following purposes, and transfer funding and positions to the DSPS general operations appropriation for the professional regulation program: (a) the Medical Examining Board, interstate medical licensure compact, and the prescription drug monitoring program general program operations [s. 20.165 (1)(hg)] (\$3,933,400 in 2025-26 and \$3,892,900 in 2026-27 and 21.71 positions); (b) proprietary school programs [s. 20.165 (1)(jr)] (\$837,900 annually and 6.6 positions); (c) student protection [s. 20.165 (1)(jt)] (\$56,600 annually); and (d) closed schools and preservation of student records [s. 20.165 (1)(jv)] (\$12,100 annually). Modify the professional regulation general program operations appropriation to allow expenditures for licensing, rulemaking, and regulatory functions related to all functions previously fulfilled by the repealed appropriations. Transfer the unencumbered balance of the repealed appropriations to the general professional licensure operations appropriation on the bill's effective date. Adopt Alternative B1 to repeal the appropriation for administrative services relating to the regulation of industry, safety, and buildings [s. 20.165 (2)(kd)] (\$3,194,500 each year and 13.25 positions) and transfer the funding and positions to the operations appropriation for the regulation of industry, safety, and buildings. Modify the safety and buildings operations appropriation to allow expenditures for administrative and support services related to the

regulation of industry, safety, and buildings and accept moneys received by the Department as payment for administrative support services, which were previously fulfilled by the repealed appropriation. Modify the appropriation for interagency agreements to receive all moneys received by DSPS from other state agencies related to regulation of industry, safety, and buildings, except for money received by the safety and buildings operation appropriation [s. 20.165 (2)(j)]. Transfer the unencumbered balances of the repealed appropriation to the operations appropriation on the bill's effective date.

3. *Supplies and Services Funding (Paper #678)*. Adopt Alternative 1 to provide \$125,000 annually to increase supplies and services for contracted IT staff to assist credential holders with use of the Department's LicensE platform. Adopt Alternative 2 to provide \$84,000 annually to increase supplies and services funding for a project to improve the DSPS online credential performance dashboard.

Safety and Buildings Programs

4. *Private On-site Wastewater Treatment System (POWTS) Grant Program Update and Continuation [Paper #691]*. Adopt Alternative A1 to reinstate the private on-site wastewater treatment system grant program under provisions of current law. Provide \$840,000 each year in a continuing appropriation. Adopt Alternative B1 to change the installation deadline for POWTS grant eligibility to include systems installed at least 33 years before a person submitted a grant application. Adopt Alternative C1 to require DSPS on July 1, 2026, and each July 1 thereafter, to adjust the income limit by the percentage change in the U.S. Consumer Price Index for urban wage earners and clerical workers, U.S. city average, for the prior year, rounded to the nearest dollar. Require DSPS to publish the income limit on the Department website. Exempt the annual income change from being promulgated through the administrative rules process.

5. *Youth Volunteer Firefighter Training Program [Paper #692]*. Adopt Alternative 1 to provide \$75,000 PR each year in ongoing funding from the DSPS fire safety administration appropriation to continue the Youth Firefighter Training Grant Program.

6. *Manufactured Housing Rehabilitation and Recycling Program [LFB Summary Page 614, #4]*. Provide \$20,000 each year as one-time funding for the manufactured housing rehabilitation and recycling program.

Regulation of Professions

7. *Call Center Staff (Paper #680)*. Adopt Alternative 1 to provide ongoing funding of \$956,400 in 2025-26 and \$1,083,200 in 2026-27 with 14.0 office operations associate permanent positions to provide additional customer service call center staff within the Division of Professional Credential Processing Customer Service Center.

8. *License Processing Staff (Paper #681)*. Adopt Alternative A1 to provide 9.0 license/permit program associate permanent positions and \$797,700 each year in the Division of Professional Credential Processing. Adopt Alternative A2 to provide 1.0 paralegal and \$77,800 each

year in the Division of Professional Credential Processing.

9. *Board Support Staff (Paper #682).* Adopt Alternatives 1, 2, 3, and 5 to provide the following staff to support DSPS credentialing boards: (a) \$94,700 in 2025-26 and \$125,300 in 2026-27 and 1.0 attorney for professional regulation complaints and other compliance; (b) \$177,100 in 2025-26 and \$233,000 in 2026-27 with 3.0 paralegals for professional regulation complaints and other compliance; (c) \$126,200 in 2025-26 and \$164,400 in 2026-27 and 1.0 pharmacy practices consultant for inspections of primarily non-retail pharmacy locations; and (d) \$190,900 in 2025-26 and \$250,400 in 2026-27 and 2.0 attorney positions for the state's Prescription Drug Monitoring Program.
