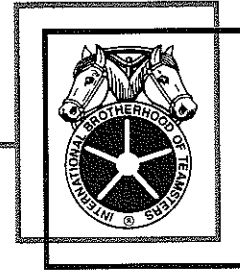


On behalf of Wisconsin Teamsters Joint Council 39, I am registering our support for the above referenced legislation.
