Mr. Jeffery Quarles:

We would like to express our profound disappointment that both the Wisconsin Veterans Housing and Recovery Programs at the Wisconsin Veterans Home at Union Grove and the Wisconsin Veterans Home at King were recently denied funding. We respectfully request the U.S. Department of Veterans Affairs to reconsider its decision to not renew the Homeless Providers Grant and Per Diem Program grants for these housing programs at Wisconsin's facilities for veterans. We are also requesting our federal delegation's assistance and advocacy to accomplish this appeal.

Homeless veterans in our state will undoubtedly suffer without this vital funding which they have relied on since 1997 at the Veterans Home in Union Grove and since 1995 at the Veterans Home at King. In fact, the Veterans Home at King was the first in the country to be a part of this program and to receive funding for this laudable and necessary cause. This loss of funding will directly impact the 49 veterans who are currently housed under both of these programs, and surely many more in the future.

For some homeless veterans in our state, especially those in more northern and rural areas, there is simply an absence of necessary resources available to assist these individuals. Without the funding for these programs at King and Union Grove, there will be a lack of options for homeless veterans in certain areas of Wisconsin.

However, we are proud of the work our Wisconsin Department of Veterans Affairs (WDVA) is doing to mitigate this damaging cut in funding and to ensure each of these veterans gets the housing and assistance they need. Going forward, we know WDVA is working very closely with veteran services organizations, the VA in Milwaukee, and other veteran partners. We are happy to hear of the WDVA's confidence in its ability to find housing for all 49 veterans in its current programs by September, and that WDVA will continue to follow-up with these veterans after placement. We are confident WDVA will not leave homeless veterans without options in the future, but understand this lack of funding will greatly impact their opportunities going forward.

These veterans have made great sacrifices in their service for our country and deserve this assistance in their time of need. They have, without question, earned it. This is why we again reiterate our sincere hope that you will reconsider this decision. We are interested to hear why these veterans housing programs were not granted the necessary funding and how you will strengthen your partnership with WDVA on this issue going forward.
