Dear Attorney General Lynch:

We are writing to raise concerns related to the Wisconsin Department of Motor Vehicles (DMV) dispersing inaccurate and inconsistent information to voters attempting to obtain a valid, state-issued identification card prior to the November 8 election. As you know, Wisconsin has a voter ID law and all eligible electors wishing to cast their ballot will need a state-issued ID card to present to poll workers before voting. DMV workers have given incorrect and misleading information to individuals attempting to obtain the required voter ID.

With less than 35 days until the election, we are requesting that your department immediately investigate these claims and, if merited, take appropriate legal action to ensure Wisconsin electors hoping to vote in the upcoming election are able to do so. Members of the Assembly Democratic caucus have made a request of the state's DMV for an immediate action plan to correct the distribution of inaccurate and inconsistent information to voters hoping to obtain an ID. We do not feel that online training of employees will suffice, given the volume of DMV employees across the state who told potential electors there was "no guarantee" they would be able to vote in the upcoming election. Because eligible voters may have been turned away, we feel that federal oversight may be warranted and urge you to consider our request.

Our strong opposition to voter ID laws is only strengthened by reports highlighting the ineptitude and failure of our state's Department of Motor Vehicles, the agency tasked with issuing valid identification cards to electors. We already believe the often onerous and time-consuming process of obtaining an ID will likely be reason for some to abandon the voting process. The likelihood of this happening is only amplified when electors are receiving grossly inaccurate information about how to obtain an ID prior to the election.
