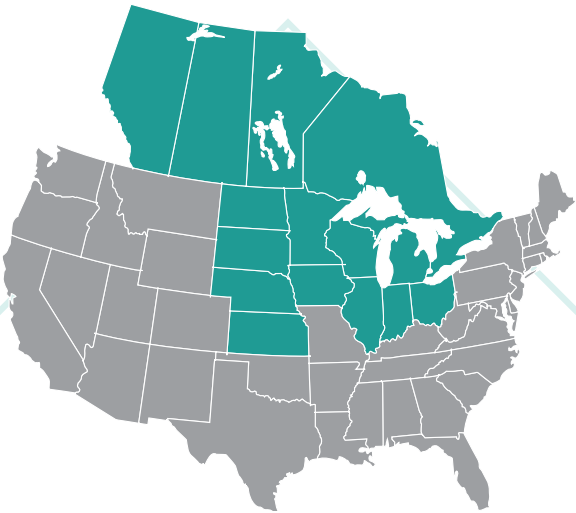
# CSG MIDWEST MISSION

## ANNUAL MEETINGS

**The MLC Annual Meeting**—the only event designed by and for state and provincial legislators from the Midwest—features a mix of renowned speakers, professional development workshops and policy sessions on issues of critical importance to this region. This year, the meeting will be held July 11-14 in Rapid City, S.D. The CSG National Conference will be held in December in Santa Fe, N.M. Additionally, throughout the year, CSG hosts virtual policy and professional development sessions for the Midwest's legislators and other state leaders.

**MEETINGS AND CONFERENCES:** Our regional and national conferences feature renowned speakers and policy sessions on issues of critical importance to policymakers and provide legislators a unique chance to network with counterparts and thought leaders from across the country.



**PROFESSIONAL DEVELOPMENT AND LEADERSHIP TRAINING PROGRAMS:** Nearly 90 current and former Wisconsin officials, including 36 incumbent legislators, are alumni of our leadership training programs. The Bowhay Institute for Legislative Leadership Development (BILLD) is the only leadership-development program designed specifically for Midwestern state legislators. The Toll Fellowship program is CSG's national leadership development program for state officials from all three branches of government.



**LEADERSHIP OPPORTUNITIES:** Wisconsin legislators have held top leadership positions as chairs of the Midwestern Legislative Conference. Legislators from the state have also helped guide CSG's efforts as members and chairs of policy committees.



**POLICY COMMITTEES:** The Midwestern Legislative Conference supports six policy committees designed to help legislators share ideas and best practices: Agriculture and Natural Resources; Criminal Justice and Public Safety; Economic Development; Education; Health and Human Services; and Midwest-Canada Relations.



**IN-STATE TRAINING:** Our Under the Dome initiative brings customized professional development and policy training to the region's capitols. In recent years, we've convened policy workshops in Wisconsin on health and well-being and on the protection and restoration of the Great Lakes. CSG has also sponsored professional development workshops on civil discourse and media relations.



**GREAT LAKES-SAINT LAWRENCE LEGISLATIVE CAUCUS (GLLC):** CSG Midwest provides staff support to the GLLC, which is composed of legislators from all 10 Great Lakes states and provinces. The caucus's mission is to promote the restoration and protection of the Great Lakes. Forty-seven Wisconsin legislators are members of the GLLC.



**STATELINE MIDWEST AND CAPITOL IDEAS:** As part of your membership in CSG, you receive copies by mail and email of our monthly publication, *Stateline Midwest*, and our national magazine, *Capitol Ideas*. Back issues of these and other publications are available on our website.



**REFERENCE MATERIALS:** Each year, CSG publishes *The Book of the States*, a comprehensive encyclopedia of state government that includes data, tables and policy articles by experts in a variety of fields.

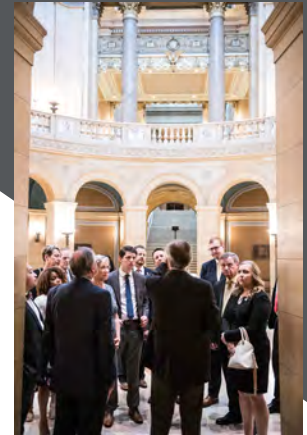

## WHY APPLY FOR A BILLD FELLOWSHIP?

**DEVELOP LEADERSHIP SKILLS** BILLD is the only leadership institute designed exclusively for Midwestern legislators. Through a series of interactive workshops, the Bowhay Institute provides training to develop and sharpen the skills you need to be a more effective legislative leader.

**IMPROVE UNDERSTANDING OF KEY REGIONAL PUBLIC POLICIES** By focusing on the most important issues that state policymakers face today, scholars from the University of Minnesota and outside experts provide a context for you to effectively analyze policies and programs, evaluate information that you receive, and communicate successfully with constituents and colleagues.

**NETWORK WITH THE BEST AND BRIGHTEST** As a BILLD Fellow, you will be joined by some of the most promising new legislators from across the region. You will have the chance to share your knowledge, learn from one another's experiences, and forge relationships that will last long beyond your time in Minneapolis.



## WHO SHOULD APPLY?

Midwestern legislators in their first four years of legislative service are eligible to apply. Fellowships are awarded based on an applicant's ability to demonstrate leadership potential, dedication to public service, and commitment to the legislative process and institution. Through a competitive application process, fellowships are awarded annually to Midwestern lawmakers from Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Nebraska, North Dakota, Ohio, Saskatchewan, South Dakota, and Wisconsin.

## HOW TO APPLY FOR A BILLD FELLOWSHIP

In addition to the application form contained in this packet, each applicant must submit two letters of recommendation, a current résumé, and a written essay. Please follow the guidelines in the “Application Components” section when completing and submitting the required materials.

All application materials must be received by CSG Midwest no later than **April 9, 2021**. Late and/or incomplete applications will not be considered. You will receive confirmation of the receipt of your application materials via email.

## ABOUT THE FELLOWSHIP

- Midwestern legislators are awarded Fellowships through a competitive, nonpartisan process by the BILLD Steering Committee – a bipartisan group of legislators from each state in the region.
- Each BILLD Fellowship covers the cost of tuition, lodging, and meals.
- CSG Midwest offers financial assistance for travel to and from Minneapolis. All Fellows will be eligible for a stipend that covers a portion of their travel costs.
- Attendance at BILLD is limited to BILLD Fellows, BILLD staff, and invited guests.
- Applicants will be notified of the Steering Committee’s decisions in mid-May.
- In order to maintain the integrity of the program, and as a professional courtesy to colleagues, individuals awarded Fellowships must confirm their attendance for the entire BILLD program. BILLD Fellows are expected to arrive by 3:00 p.m. on Friday, July 30, and depart on the morning of Wednesday, August 4. The BILLD Steering Committee reserves the right to withdraw the Fellowship of any participant unable to commit to being present for the entire program.

Completed BILLD applications must be received by CSG Midwest no later than April 9.

Please make sure that you have submitted each of the following components of your application. Late and/or incomplete applications will not be considered. You will receive confirmation of the receipt of your application materials via email message.

**(1) APPLICATION FORM** Complete the application form contained in this packet or apply online at [csgmidwest.org](http://csgmidwest.org).

**(2) WRITTEN ESSAY** Describe your qualifications for receiving a BILLD Fellowship by answering the following questions. Your essay must be limited to two typed pages.

- a. What is the policy area of greatest interest to you, and what role do you play or expect to play in addressing it?
- b. What is your most significant legislative accomplishment or skill that demonstrates your ability as a legislator?
- c. What is your most significant personal or professional accomplishment outside the legislative arena that demonstrates your commitment to public service?
- d. There are a number of ways to exercise leadership. How would you describe your personal leadership style, and how do you effectively demonstrate leadership in the legislature?

**(3) CURRENT RÉSUMÉ** Your résumé must be limited to two typed pages and include the following information, as applicable. Please use bullet points rather than paragraph format.

- Legislative background (first elected/appointed; number of years of legislative service)
- Legislative committees on which you currently serve
- Current and/or previous leadership roles in the legislature
- Prior elected office(s)
- Community service/volunteer activities
- Occupational and educational background

### **(4) TWO LETTERS OF RECOMMENDATION**

Submit two personalized letters of recommendation, written by state legislative colleagues and/or graduates of the Bowhay Institute (please note that members of the BILLD Steering Committee are not permitted to write letters of recommendation). Do not submit more than the two required letters of recommendation, as only two letters will be considered by the Steering Committee.
