White House issues new eviction moratorium

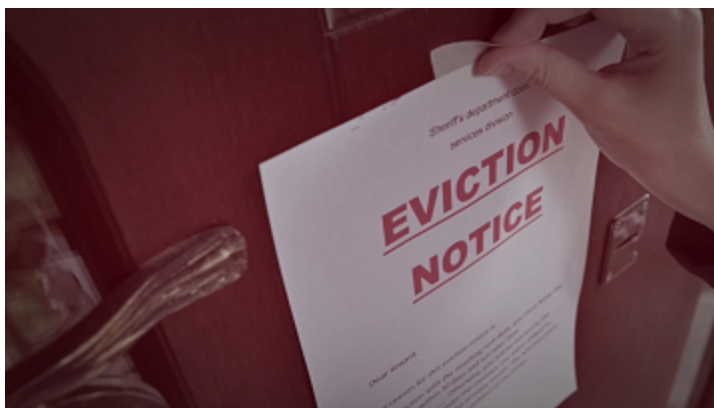

The new moratorium was issued in response to rising numbers of new cases throughout the country, mostly attributed to the Delta Variant of the Coronavirus.

This moratorium will last for 60 days, and is targeted to apply to counties where transmission of COVID-19 is still high.

This new moratorium will be in effect for 60 days, ending October 3rd, 2021.

To qualify for the protections, a renter must provide a completed and signed copy of a declaration with the elements listed in [the definition of "Covered Person"](#) (Page 2) to their landlord or the owner of the property where they live.

From Order Page 14:

Any written document that an eligible tenant, lessee, or resident of residential property presents to their landlord will comply with this Order, as long as it contains the

required elements of "Covered person" as described in this Order. In addition, tenants, lessees, and residents of residential property are allowed to declare in writing that they meet the elements of "Covered person" in other languages.

All declarations, regardless of form used, must be signed, and must include a statement that the tenant understands that they could be liable for perjury for any false or misleading statements or omissions in the declaration.

Campaign Integrity Package circulated in the Legislature

I was very proud to join several of my colleagues as we unveiled the *Campaign Integrity Package* of bills yesterday at the Wisconsin State Capitol.

This package of 7 bills would rein in political spending and demand transparency for political contributions. There should be no more fiscal tricks that allow dark money to influence our politics. The people deserve to know when large donations are made that would influence the decisions of their representatives.

One of the bills would put a referendum of the November 2022 statewide ballot to ask voters if Congress should propose an amendment to override the *Citizens United v. FEC* decision of the U.S. Supreme Court.

New Hours for COVID-19 Testing and Vaccination Centers in Milwaukee

To ensure easily accessible COVID-19 testing and vaccinations for everyone, the Milwaukee Health Department is adjusting the hours of the Northwest Health Center (7630 W. Mill Rd.) and Southside Health Center (1639 S. 23rd St.). Additionally, all COVID-19 services at the Northwest Health Center will be moved out of the former Mill Road Library and into the detached garage.

Beginning Monday, August 2, the hours for COVID-19 testing and vaccination at both locations will be:

Monday: 9 a.m. – 3 p.m.

Tuesday: 12 – 6 p.m.

Wednesday: CLOSED

Thursday: 12 – 6 p.m.

Friday: 9 a.m. – 3 p.m.

Saturday: 9 a.m. – 1 p.m.

Sunday: CLOSED

Drive-thru COVID-19 testing continues at American Family Field every Monday, Wednesday, Friday, and Saturday from 9 a.m. until 3 p.m. in the east parking lot, designated as the “Yount Lot.” Rapid antigen tests will additionally become available at this location at a future date.

Speaker Vos and Assembly Republicans Double Down on the Big Lie

Republicans at the State Capitol are determined to spread false information about the elections that are held in our state. This comes after a decade of Republican overhauls to our elections system in Wisconsin, including completely eliminating the Government Accountability Board and then axing the leaders of the Wisconsin Elections and Ethics Commissions, which they themselves had created.

Recently, Speaker Vos has announced that he will be expanding the scope of the election "investigation" that he created, headed by former Wisconsin Supreme Court Justice Michael Gableman who Vos has named "special counsel." Earlier this month, the two former police officers who were also hired to conduct the investigation quit the affair.

Vos has agreed to pay Gableman \$44,000 in taxpayer money to lead the investigation, and recently approved additional investigators with full-time positions. Vos has not made clear how many additional "investigators" he intends to hire using public resources. Gableman has previously claimed that the election was "stolen" during a pro-Trump rally.

No evidence has been brought forward that indicates widespread fraud occurred during the 2020 election, and courts have repeatedly rejected lawsuits filed on behalf of Donald Trump and his allies who have tried to overturn the results of the election in Wisconsin and other states.

In addition to Vos' investigation, the Assembly Elections Committee has been granted subpoena power by the Assembly Republicans. The committee's chairperson, Representative Janel Brandtjen has said that the committee will seek additional election records to complete a "comprehensive, forensic examination" but hasn't provided any details about what that means.

The Wisconsin Elections Commission had to issue a [statement on misinformation](#), after Rep. Brandtjen incorrectly alleged that "tens of thousands of new registrations and votes

cast by individuals whose driver's license number, name, and date of birth did not match and were subsequently removed from the state system after their votes were recorded..."

Today we learned that Representative Timothy Ramthun is attempting to secure donations for *a fourth investigation* of the 2020 general election (Including Vos', Brandtjen's, and the [Legislative Audit of the election](#)). He used common QAnon themes in his promotional video for his efforts.
