### **VICTORY FOR MARRIAGE EQUALITY!**

On Friday, U.S. District Judge Barbara Crabb declared Wisconsin's ban on same-sex marriage unconstitutional. In 2006, voters amended the Wisconsin Constitution to outlaw gay marriage. The American Civil Liberties Union filed a lawsuit in February on behalf of eight couples, challenging the ban. The lawsuit argued that the ban violates one's

constitutional right to equal protection and due process. Last Friday, Crabb issued a ruling stating same-sex couples "are entitled to the same treatment as any heterosexual couple." Milwaukee and Dane county officials began issuing marriage licenses immediately. Still, there was confusion throughout the state as to whether or not the ruling was meant to take effect immediately. Wisconsin Attorney General J.B. Van Hollen says he will seek an emergency federal court order to stop the marriages and take the ruling to the U.S. Court of Appeals, asking for an emergency stay to halt the marriages. In the past week, nearly 500 marriage licenses have been issued statewide, 183 of those in Milwaukee county alone. Congrats to all the happy couples!

### CHECKING UP ON WISCONSIN HEALTH CARE

Last Tuesday, the Senate Health Committee and the Wisconsin Hospital Association (WHA) held a briefing to explain the state of health care in Wisconsin. WHA and the health committee clarified some of the health care goals in Wisconsin such as

transparency and patient-centered care. They also explained Checkpoint, an online source where hospitals provide information voluntarily, such as patient satisfaction data that demonstrates the quality of care at different state facilities. The Checkpoint assessment of the two hospitals in the 4th district, Colombia St. Mary's Hospital and Orthopedic Hospital of Wisconsin, show that both hospitals are better than the national average on Patient Experience, exemplifying the commitment to patient centered care. High quality care is a Wisconsin advantage for businesses, patients, and employees and Wisconsin is a leader among the country in high quality care! Our next step is to ensure that all citizens have access to the exceptional service provided by our hospitals.
