**GOVERNOR VETOES GUN BILL
THAT PASSED THE SENATE 29-1**

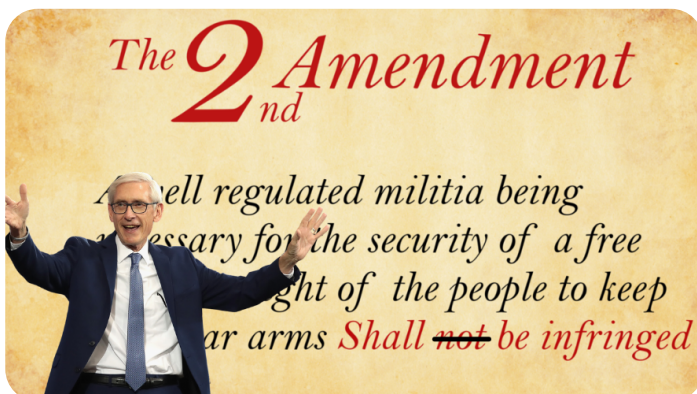
On Friday afternoon, in an effort to avoid attention, Governor Evers quietly vetoed Assembly Bill 293 which would have made Wisconsin a 2nd Amendment sanctuary state.

This legislation had bi-partisan support in both chambers, including a voice vote in the Senate (something the Senate Minority Leader agreed to), with only one democrat registering a vote against it.

Wisconsinites want assurances that they're going to be able to protect their families with the rights afforded to them by the U.S. Constitution, regardless of which party controls Washington D.C.

The Governor vetoed a bill that twenty-nine of thirty-three state senators voted in favor of.

With this veto, Governor Evers is telling all of us that he places his faith in Washington politicians over the people of his own state.

The most influential way to get involved and raise your voice is through the government that's closest to you - town, village, city, and county boards.

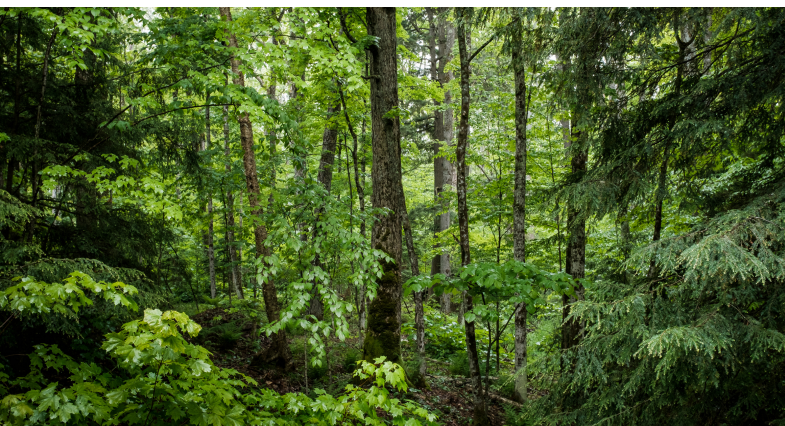
Congrats to the patriots in Maple Valley who made this happen. Your constituents appreciate your willingness to defend their right to protect their families.
