Yesterday, my Committee on Insurance, Licensing and Forestry held an executive session to recommend bills for passage on the Senate floor and a public hearing on another set of bills/appointments to hear testimony from Wisconsinites and the industries involved.

### Executive Session

- **SB233**: Relating to: procedures for granting credentials granted by the Department of Safety and Professional Services
- **SB293**: Relating to: marriage solemnization requirements and marriage document requirements, issuance, and validity

### Public Hearing

Yesterday, I testified on my bill to allow Expanded Function Dental Auxiliaries (EFDAs) in Wisconsin, which is a member of the dental team in over 20 other states and the military, that assists dentists and dental hygienists.

While this bill won't solve the access issue on its own, I believe it will help everyone in a dental office operate at the top of their scope. This, in conjunction with reimbursement rate increases we just passed in the budget and hopefully dental therapy later this session, will go a long way to getting all Wisconsinites the care they need.
