

## Grant Funding Available to Racine Small Businesses



Racine County Economic Development Corporation (RCEDC) and Racine County have been awarded a \$500,000 grant from the Wisconsin Department of Administration to help area small businesses impacted by Covid-19. In order to qualify for grant funding, businesses must be located in Racine County; have five employees or fewer; and have been negatively impacted by Covid; in addition, a majority of the business's employees must be making low to moderate wages. While all qualified businesses are encouraged to apply, RCEDC and Racine County are urging minority-owned, womenowned and veteran-owned businesses to seek grant funding. # Supreme Court Ruling in Case Brought by GOP Donor to Cost State More Than \$50 Million per Month in Federal Food Aid

As expected, the state Department of Health Services has confirmed that the state Supreme Court ruling eliminating Governor Evers' emergency order on Covid and the statewide masking requirement will cost the state between \$50 and \$70 million per month in federal food aid, beginning in May. The lawsuit that led to the Supreme Court decision was brought by major Republican donor Jere Fabick, who had also donated to Supreme Court Justice Rebecca Bradley, and backed by state Republicans. The increased federal food aid money was made available through the federal CARES Act to states with an active Covid-19 emergency order. According to Sherrie Tusler of the Hunger Task Force, many low-income seniors who are currently receiving \$204 per month in food assistance will see their aid drop to \$16 per month as a result.



# Vaccinations are Up, but so are New Covid Cases

All Wisconsinites age 16 and older are now eligible for the Covid-19 vaccine, and Wisconsin remains among the national leaders in vaccine distribution. That's the good news. The bad news is that

Wisconsin is among a number of states seeing an increase in new Covid-19 infections, including among children. An outbreak at a daycare center in Dane County resulted in at least 35 newly infected, including 16 children. Nationally, CDC Director Rochelle Walensky reported this week that the so-called "UK variant", which is more contagious and more dangerous, is now the dominant strain of Covid-19 in the U.S. Our neighboring state of Michigan is currently seeing the worst surge in the nation, and our other surrounding states, Minnesota, Illinois and Iowa, are seeing steep increases, as well. Vaccination will bring us some return to normalcy, but we aren't there yet. We all need to step up to get vaccinated when it is our turn, and in the meantime, we must continue to follow CDC recommendations - wear a mask, avoid gatherings, wash your hands.

Kenosha County operates a Covid-19 Vaccine Call Center. The call center is open to people who don't have access to schedule a vaccination appointment online. These people can call (262)605-6799 to speak with someone who will walk them through the appointment process, if they are eligible. The new Kenosha County Covid Vaccination Clinic site, located inside the former Shopko at 5300 52nd St., is now operational. You can use the above link to find appointment times.

The Grace Welcome Center in Kenosha, 2006 60th St., will be hosting a Kenosha County Health Department vaccination clinic on April 13, 20 and 27 and May 4, from 2:00 - 5:30 pm. No appointments are necessary.

## Protect Yourself Against Covid-19 Vaccination Scams

The state Department of Agriculture, Trade and Consumer Protection is sounding the alarm about the potential for new scams surrounding the Covid-19 vaccination. The number one message they want consumers to know is: **You cannot buy the vaccine.** It is only available at federal- and state-approved locations like health care clinics, local health departments, and community vaccination centers. With vaccine supplies still limited in some communities around the state, the Department is concerned that some people, desperate to vaccinate themselves or family members, will fall prey to scams requesting payment for "vaccinations". The Federal Trade Commission has reported nearly 3,000 Covid-related scams in Wisconsin in the last year; DATCP says that's likely the tip of the iceberg, as most go unreported. DATCP offered these tips to avoid being scammed: (1) **Use reliable information when it comes to the latest on vaccines.** These include your doctor, local health department or local news

outlets; (2) **Don't click on links in unsolicited emails or texts**; (3) **Again - you will never have to pay out-of-pocket to get the Covid vaccine.** The federal government will not call, email or text you looking for personal or financial information, so don't hand it out. # Governor Evers Commits \$46 Million in Stimulus Funds to New Round of "We're All In" Small Business Grants

An estimated 9,300 Wisconsin small businesses will receive financial assistance through a new round of "We're All In" grants announced this week by Governor Evers, the state Department of Revenue, and the Wisconsin Economic Development Corporation. A total of \$46 million is being allocated to this round of grants, with each awardee receiving \$5,000. Demand for the last phase of the grant program exceeded funding, so those businesses that applied last time but weren't chosen will be given first priority. To find out more, go to

## Kenosha County Kickstart Plan Amended to Include Guidance on Large-Scale Public Events

Last year, Kenosha County, in conjunction with its municipalities, local officials and business leaders, released the Kenosha County Kickstart Plan, a roadmap for resuming operations after Covid-19 shutdowns. This week, an addendum to the Kickstart Plan was released, offering guidance on large-scale events. The addendum reflects the fact that when the original plan was released, no large-scale events were being held. The new section divides events into three risk categories - Low, Medium, and High Risk. ### Local Covid Testing Options

There are a number of options locally for anyone looking to get tested. Your primary health care provider is always an option, but there are many community testing sites available, as well.

CVS Pharmacy: Drive-through testing available at CVS in Kenosha (3710 57th Ave.) and Racine (3915 Durand Ave.); advance registration required at <a href="https://www.cvs.com/minuteclinic/covid-19-testing">https://www.cvs.com/minuteclinic/covid-19-testing</a>

**Froedert South:** Drive-through testing is available to those who qualify after completing an initial phone evaluation at (262)671-7777 between 8 am and 4:30 pm Monday-Friday

**Kenosha Community Medical Center:** A drive-through testing site at the former Chase Bank, 5506 Seventh Ave., is open to patients who complete a quick registration process at <a href="https://www.kenoshachc.org/covid-19-resource-center/">https://www.kenoshachc.org/covid-19-resource-center/</a>. Testing is conducted Mondays, Wednesdays and Fridays from 8 am to 4 pm.

Old Kenosha Fire Station No. 3: Free, drive-through testing will be offered during the following hours at the former No. 3 Fire Station, 2121 Roosevelt Rd., Kenosha: Tuesdays, 2-6 pm; Thursdays, 2-6 pm; Saturdays, 9 am - 1 pm. This testing is being offered in a partnership between locally-owned Modern Apothecary, the Wisconsin DHS, and the Kenosha Fire Department. An appointment and preregistration is strongly encouraged, with appointment times available at <a href="https://modernapothecary.10to8.com">https://modernapothecary.10to8.com</a> and registration available at <a href="https://register.covidconnect.wi.gov">https://register.covidconnect.wi.gov</a>. Anyone who lives or works in Wisconsin, ages 5 and over, can be tested.

UW System schools statewide, including Parkside, have been provided with a limited number of rapid-result Covid-19 tests. These tests provide results in 15-30 minutes. The tests are free of charge and available to the public, and you don't have to have symptoms to get a test. A positive rapid test will need to be confirmed with the regular Covid-19 test but will provide you some guidance on whether or not you need to quarantine during that period. Registration at <a href="https://www.doineedacovid19test.com">https://www.doineedacovid19test.com</a> is required. The tests are administered in De Simone Gym in the SAC on the Parkside campus Monday-Thursday, 9 am - 5 pm, and Friday, 9 am - 1 pm. Testing is expected to last at least several weeks.
