AG Kaul Calls for End to Sham Election Investigation; Gableman, Who Says He Doesn't Understand How Elections Work, Didn't Vote in Seven Recent Elections

Wisconsin Attorney General Josh Kaul held a press conference earlier this week, during which he called for an end to the "fake investigation" into the 2020 election authorized by Assembly Speaker Robin Vos and led by former state Supreme Court Justice Michael Gableman. "This is not a serious investigation. Even if an investigation like this were justified – and it's clearly not – this one suffers from glaring flaws that destroy any credibility that its results could have. In addition, this investigation isn't being professionally or competently conducted. It's clear that the investigators here are learning the basics of election administration as they go," Kaul said. The last statement is a reference to a recent admission by Gableman that he does not understand how elections work. Meanwhile, an investigation by the Milwaukee Journal Sentinel found that Gableman had not voted in Wisconsin in seven elections over the last three years, including the 2018 race for Governor and the 2020 race for state Supreme Court.



Global Energy "Perfect Storm" Will Likely Cause Winter Heating Bills to Soar


A surge in energy demand worldwide, combined with supply constraints, will likely result in Wisconsin residents paying more to heat their homes this fall and winter. On Wednesday, the federal Energy Information Administration forecast steeply higher heating bills for all U.S. households, regardless of the weather. The Midwest is expected to be hardest hit, with some households spending up to 69% more. For now, the added costs will affect gas bills, but customers could see an impact on their electricity bills starting early next year. What's more, the National Oceanic and Atmospheric Administration predicts that this winter will be slightly colder than average, which could increase costs even more. The Public Service Commission is recommending that propane and heating oil customers fill up their tanks soon, as prices are expected to rise throughout the winter. The Citizens Utility Board encourages residents who are struggling financially to apply for energy assistance grants and those who can afford it to consider replacing old furnaces or adding insulation to their homes. Financial help is available from the state's Home Energy Assistance Program (WHEAP) for households earning less than 60% of the state median, which works out to about \$50,000 for a family of three. Help is also available from the nonprofit Keep Wisconsin Warm/Cool Fund. The state estimates that 205,000 households will receive an average of \$388 to offset heating costs this winter and about \$195 for electricity.



State Dept. of Administration to Hold Listening Sessions on WI Clean Energy Plan

The Wisconsin Office of Sustainability and Clean Energy has announced a series of listening sessions to gather public input in developing the Wisconsin Clean Energy Plan. Established by Governor Evers, the Office of Sustainability and Clean Energy is partnering with state agencies and utilities to develop a plan that will ensure 100% carbon-free electricity consumption in Wisconsin by 2050. The first-ever Wisconsin Clean Energy Plan will also help the state

mitigate climate change impacts through the use of clean energy resources and technology, while promoting workforce training, sustainability standards, and environmental justice. Topics covered in the listening sessions will include: Economic and Environmental Justice; Infrastructure and Industry; Transit and Transportation; and Clean Energy and Energy Efficiency. The first session, on Economic and Environmental Justice, will be held on October 19 from 6 – 8 pm. Registration is not required but it recommended. The full schedule can be found here.
