Submitted Your Absentee Ballot and Your Chosen Candidate Has Dropped Out? How to Nullify your Ballot and Change your Vote

If you have already submitted your absentee ballot for the Aug. 9 primary and a candidate you supported has since dropped out of the race, it is possible to have your ballot "spoiled" or "nullified", allowing you to obtain a fresh ballot. According to the Wisconsin Elections Commission, a voter can request to spoil their ballot through either a handwritten or emailed note to their local elections clerk or in person at their polling place. Voters must provide a reason in their request that outlines why they require a new ballot. Casting a vote for a candidate who is no longer in the race is a valid and acceptable reason to spoil a ballot. If/when the request is approved, the clerk will mail a new ballot. If a voter wishes to spoil their initial ballot by mail, they must do so by no later than 5 pm on Thursday, August 4; for indefinitely confined voters, the deadline is August 5. For those who choose to spoil their first ballot in person, the deadline is August 6. You won't be able to do so at the polls on Election Day.




Wisconsinites with Disabilities Sue Over Voting Rights

Four Wisconsin residents living with disabilities have filed a lawsuit over a voting rights infringement. A recent Wisconsin Supreme Court ruling prohibits the use of absentee ballot drop boxes and requires voters themselves to return their own absentee ballots; Republicans who control the Legislature's Joint Committee for Review of Administrative Rules last week struck down a rule allowing municipal clerks to correct minor errors on absentee ballot envelopes. Advocates for the disability rights community say both of these actions with negatively impact the ability of people living with disabilities to cast their ballots. Democracy only works when all voices can be heard, and Wisconsin Republicans continue to make that more and more difficult.



Deadline Approaching to Take Advantage of Debt Forgiveness Waiver

Higher education can open the door for opportunity and learning, but often it comes with cripplingly large amounts of student debt. This can lead to major struggles, especially for those who are paying for it on their own. The Biden Administration has been working to lessen this burden for students, and at least one type of loan forgiveness is more accessible than ever. In October 2021, the Administration announced a waiver to lessen restrictions for the Public Service Loan Forgiveness program, available to those who have worked for a government agency or non-profit organization for at least 10 years and have direct federal loans. This waiver expires October 31st, 2022, so time is short to take advantage of this waiver. I urge anyone who is still struggling under their student loans to confirm their eligibility before time runs out. SapSap Owner Recognized for Community Involvement



EIGHT MORE Free Covid Tests Available

With Covid cases again on the rise, the Biden administration has is offering households eight additional at-home Covid tests, free of charge. You can order the eight tests at https://www.covidtests.gov/; you can also use this site to find nearby testing locations. The administration had previously made four at-home Covid tests available per household; you can still claim those using the same link if you haven't already done so. Additionally, because of actions by President Biden and Governor Evers, your health insurance provider may be required to cover up to eight at-home rapid tests per month.
