This week, President Joe Biden held a signing ceremony at the White House where he signed the "Respect for Marriage" Act into law. The new law, which was passed through the hard work of Wisconsin's own Sen. Tammy Baldwin, provides important protections for people in same-sex and/or interracial marriages.



Wisconsin State Building Commission Approves Funding for Projects at Parkside, Bong

The State of Wisconsin Building Commission is an eight-member board consisting of the Governor, who chairs the board; three members of both the State Senate and State Assembly; one citizen member appointed by the Governor; and three non-voting advisory members from

the Department of Administration (DOA). The Building Commission is tasked with developing and implementing the state building program, as well as issuing bonds for the state.At its December 14 meeting, the Building Commission gave approval to several local projects, one related to the Bong Recreational Area and a couple of upgrades on the UW-Parkside

campus.

The Bong project involves construction of a 90'x50' building to be used for the daily operations and maintenance activities of fisheries and wildlife management. Construction of the new building is expected to provide cost savings due to reduction or elimination of lost staff time, truck mileage and wear and tear of equipment.

Approved renovations to the Parkside campus include replacement of wooden stairs, railings, balconies and walkways at the University Apartments and replacement of two heating and chilling plant boilers.



Scams to Avoid this Holiday Season

The state Department of Agriculture, Trade and Consumer Protection (DATCP) has released details on various scams to be on the lookout for this holiday season. These include:

- **Delivery notification/shipping scams**: Fake shipping may send consumers messages alerting them to a delivery and threatening to delay unless the consumers "verify" private information. Sometimes there is an attachment to download, usually containing a virus. Do not open these messages or provide any personal information. Contact the company directly using a verified customer service phone number or email address for a shipping status update.
- **Giveaway scams**: Consumers may receive messages claiming they have won a prize such as a gift card to a major retailer. The catch: consumers are asked to pay a small "processing fee" to complete a survey, or to provide some personal data before they can claim it. Prizes do not require fees. Never engage with someone offering gift cards or other goods for "free" but with strings attached.
- Online marketplace scams: Social media platforms and other online marketplaces offer the option to buy and sell directly with other users. Scammers may pose as buyers or sellers and have a variety of strategies they use to fool consumers. Be wary of buyers overpaying with checks – this is a sure sign of fraud; do not refund them. Do not pay for items unless the seller can be confirmed as legitimate. Do not give personal information or move the conversation to an off-site channel.

• **Pet scams:** Pets are a popular holiday gift, but consumers should use caution when buying one online. Scammers will advertise pets, and when contacted claim the pets were already sold but that they know a faraway second seller with more options. Ask for the name and location of the pet's veterinarian. Contact the vet using publicly available information to confirm the pet really exists. Never pay up-front for pets sold online.

• **Ticket scams:** Tickets to popular events can be expensive and in short supply. While many unofficial sellers and third-party websites are legitimate, watch for unreasonable prices and fake ticket sales. Purchase tickets from official vendors that have established policies for cancellations and refunds.

Wisconsin residents can now get Covid-19 tests sent to them free of charge from the state. The Wisconsin Dept. of Health Services (DHS) says that the <u>Say Yes! Covid Test website</u> is now live and operational. The site allows households to order five rapid tests for free **each month.**

Households can still get up to eight rapid Covid tests per month through their insurance providers, as well.
