Currently there are only four FDA-approved drugs for treating glioblastoma, and the cause remains unknown. To raise awareness of both the illness itself and the critical need for more research, July 19, 2023, has been declared Glioblastoma Awareness Day. Milwaukee Common Council Approves 2% City Sales Tax

On Tuesday, the Milwaukee Common Council approved, on a 12-3 vote, a 2% citywide sales tax. The ability for both the City of Milwaukee and Milwaukee County to levy a sales tax was granted by a bill passed in June by the State Legislature and signed into law by Governor Tony Evers. Milwaukee leaders said that the additional sales tax was needed to help the city and county stay solvent as they deal with rising unmet pension obligations. If it was not approved, Milwaukee Mayor Cavalier Johnson warned that essential services would have to be cut by as much as 40%, and current and former city and county employees could lose up to 40% of their pensions. Under the state legislation, the sales tax proposal required the approval of 2/3 of the Council; that means 10 out of the 15 alders had to support it for it to be enacted. The Milwaukee County Board is still considering its own additional sales tax; a 2/3 vote is needed in their case, as well.



Evers Veto of Republicans' Tax Cut for the Rich Leaves State with \$4 Billion Surplus

The partial budget vetoes issued by Governor Tony Evers, including vetoing Republican tax cuts for earners in the top two tax brackets, leave the state with a \$4 billion surplus, according to the nonpartisan Legislative Fiscal Bureau. With divided government, it is unlikely any big spending measures will pass during the remainder of the legislative session, meaning the \$4 billion surplus will roll over into the next budget cycle.

The Emmy Award-winning reality cooking show "Top Chef", which airs on the Bravo network, has announced that it will be filming its upcoming 21 season in Madison and Milwaukee, as well as Door County and other parts of Wisconsin. The show brings together accomplished chefs from all walks of life to compete in various challenges until just one is left standing and declared the "Top Chef". In recent seasons, the show has traveled to various locations – Portland, Chicago, Kentucky, Boston, London and San Francisco, to name a few – and highlighted regional cuisine and ingredients. The show is expected to start shooting the new season in late summer/early fall, with an airdate likely in spring or early summer 2024. The Evers administration, specifically the Wisconsin Economic Development Corporation and state Department of Tourism, partnered with a number of statewide and regional organizations to bring "Top Chef" to Wisconsin.



State Officials Alert Consumers to Misleading Home Warranty Mailings

Officials with the state's Office of the Commissioner of Insurance (OCI), Department of Financial Institutions (DFI) and Department of Agriculture, Trade and Consumer Protection (DATCP) are alerting consumers about a surge of suspicious mailers being sent regarding home warranties.

The mailers often warn consumers that their "home warranty may be expiring or may have already expired," and ask for payment. The mailers are scams and should not be answered. Some letters may even include the name of your mortgage company to make the solicitation

seem more legitimate. Do not let this fool you; the name of your mortgage lender and servicer are public records and can be found online.

Look for these red flags when encountering suspicious home warranty mailers:

- Use of threatening language or unnecessary urgency (such as "final notice", "immediate response requested", "we reserve the right to revoke your eligibility for service coverage after 5 days")
 - It appears to be from a government entity but does not include specific details (for example, "home warranty division" or "lender services")
- Information that does not match your circumstances (like stating that your home warranty may be expiring when you don't actually have a home warranty)
 - There is no return address and the only contact information given is a phone number
 - A fake check is included in the mailer.

The safest course of action is to not respond. Do not call the phone number listed on the mailer; the person on the other end of the line is likely seeking your personal information. Veterans Have Until Aug. 9 to Apply for Backdated Disability Payments under PACT Act

The federal Pact Act has been called the most significant expansion of benefits and services for toxin-exposed veterans in more than 30 years. It was signed into law by President Biden on August 10, 2022. The Act removed the need for veterans to prove a service connection if they are diagnosed with certain cancers or respiratory conditions; under the law, the conditions are presumed to be connected to veterans' exposure to burn pits, Agent Orange or other toxins during their service. This makes it easier and faster for impacted veterans to collect disability benefits and receive VA health care for their illnesses.

An important date related to the PACT Act is quickly approaching. Veterans and survivors who file a VA claim – or complete an "Intent to File" form - before August 9, 2023, will be eligible to receive disability payments retroactive to August 10, 2022, when Biden signed the bill into law.
