Governor Walker,

Thank you for taking the time to meet with Senator Scott Fitzgerald and Speaker Robin Vos to seek a solution to address the transportation needs of our state. I know we all agree that our roads and highways are the lifeline to our businesses and the backbone of our state. The proposal that you outlined yesterday is a positive step forward in our desire to find a long-term solution and we believe the leadership that you have displayed has bridged the gap between our two houses. The Wisconsin State Assembly majority leadership team has deliberated on your suggestions and accept your proposal.

The Wisconsin State Assembly has stood strong on finding a comprehensive solution to our transportation funding challenges; we have to reduce the more than \$1 billion deficit and continue to improve our state's infrastructure system. We believe the broad framework that you provided is responsible because it acknowledges that the state should not issue more transportation bonds without having a sustainable way to pay for that debt.



As the legislative session continues, we look forward to continued discussions with the goal of finding a long-term, stable solution.



Thank you again for your leadership on this issue.


