Dear Honorable Members of the Wisconsin Delegation:

The undersigned Wisconsin State Legislators are writing today to thank you for your past support of the Maternal, Infant, and Early Childhood Home Visiting Program (MIECHV) and urge your support of a robust and timely reauthorization of the program by September 30, 2022.

As you know, MIECHV is a federal grant program that supports voluntary, evidence-based early childhood home visiting for families from pregnancy through kindergarten entry. In Wisconsin, MIECHV-funded home visiting supports families by promoting interventions to improve maternal and infant health; creating connections between caregivers, the pediatric medical home, and other health practitioners in the community; providing screening for perinatal depression and connecting parents with appropriate community-based behavioral health care; supporting families in their child's early development and learning; providing referrals when certain risk factors, including trauma or domestic violence, are present in the home; providing resources for children who experience trauma and toxic stress; targeting the social determinants of health affecting families; and helping families navigate complex community-based systems of supports.

In Wisconsin, we have seen the positive impact of home visiting programs and the need for more access. As you work together to reauthorize MIECHV, we respectfully request an increase in MIECHV funding to better meet the current need of eligible families and to continue to allow

virtual home visiting as an option for families. Despite the program's success, MIECHV has not received an increase of funding in nearly a decade. Pre-pandemic estimates show MIECHV reached only three to five percent of eligible families each year. Increasing MIECHV funding will allow more Wisconsin families to access this needed service. Additionally, during the pandemic, Congress adapted home visiting policies to allow for virtual home visits. This program change benefited both participating families and home visiting providers. Going forward, we request that virtual home visiting be permitted as an optional service for families.

The current MIECHV is set to expire on September 30, 2022. In order to ensure that there are no disruptions in home visiting services, we hope that you will take timely action on reauthorizing the MIECHV funding.
